# **SUMMARY:**

This funding is received from the Nevada Department of Health and Human Services to support the collaboration between Washoe County and the Division of Public and Behavioral Health. The goal of this Jail Based Mental Health Program is to introduce treatment at an earlier time in the assessment prior to adjudication of individuals with mental illness. The overarching goal and expectation of this Jail Based Mental Health Program is to mirror the intensive therapy clients receive at Lakes Crossing Center, the state operated maximum-security psychiatric facility providing comprehensive forensic mental health. During the 2025 legislative session, Nevada passed Assembly Bill 467 authorizing the establishment of programs for competency restoration at locations other than a state forensic facility. The Washoe County Jail has received this authorization from the Administrator of the Division of Public and Behavioral Health. When individuals are court ordered to receive evaluation and/or treatment for restoration to legal competency, the Washoe County Jail will provide these services under the authorization of the Division of Public and Behavioral Health. The Washoe County Jail Based Mental Health Program will reduce the time needed for evaluation and competency restoration for legal proceedings.

Washoe County Strategic Objective supported by this item: Vulnerable Populations; Coordination between agencies and communication programs.

# **PREVIOUS ACTION**

On April 23, 2024, the Board of County Commissioners approved item #17, the Departments request to accept \$5,889,962 (no County match) in ARPA funds to support the Jail-Based Mental Health Program for the period March 15, 2024 – December 30, 2025, authorized the creation of 10.0 FTE Deputy Sheriff positions and 1.0 FTE Sergeant funded 100% by these grant funds.

#### **BACKGROUND**

The Nevada Division of Public and Behavioral Health has extended the grant term and increased funding to support ongoing and enhanced program services. Funds are to be utilized by the Washoe County Sheriff's Office to continue services that have been in place since April 2024. In addition, enhancements will include forensic competency restoration under guidelines set forth by the Nevada Division of Public and Behavioral Health, additional resources in the form of medical and custodial personnel, as well as in the type of treatment provided. The program will remain a standalone team with a total of 15.0 FTE.
