SUBJECT: Rescinding General Provisions (020.005 to 020.095), Source Registration and

Operation (030.000 to 030.3104), and Emergency Episode Plan (060.010 to 060.025) of the EPA-Approved Air District Regulations in the Nevada SIP for

Washoe County

Dear Ms. Carr:

The Northern Nevada Public Health, Air Quality Management Division (AQMD) is requesting to rescind the General Provisions (020.005 to 020.095)<sup>1,2</sup>, Source Registration and Operation (030.000 to 030.3104)<sup>2,3,4</sup>, and Emergency Episode Plan (060.010 to 060.025)<sup>1,5</sup> of the EPA-Approved Air District Regulations in the Nevada SIP for Washoe County.

On October 26, 2023, the District Board of Health (DBOH) adopted revisions to CHAPTER 020 – General Provisions in order to address the conditional approval of public notification requirements of Clean Air Act Section 110(a)(2)(J) and was subsequently submitted for inclusion into the Nevada SIP for Washoe County. There have been prior amendments (4/88, 10/28/92, and 10/20/93) and revisions (4/22/98, 8/26/04, 11/16/06, 5/28/18) that were locally adopted, by the DBOH, but not federally approved since the original General Provisions (020.005 to 020.095) were adopted in 1972 and some rules were revised/amended in 1979. The SIP Submittal for the 10/26/23 adoption of CHAPTER 020.000 – General Provisions (PARTS 020.000, 020.100, and 020.200) will replace General Provisions (020.005 to 020.095) listed in Table 1 (or here: https://www.epa.gov/air-quality-implementation-plans/nevada-sip-washoe-county).

On September 26, 2024, the DBOH adopted revisions to CHAPTER 030 – Source Permitting and Operation and was subsequently submitted for inclusion into the Nevada SIP for Washoe County (See Attachment 2). There have been prior amendments (4/89, 6/27/90, 10/24/90, 9/23/92 7/28/93, 10/20/93, 11/16/94) and revisions (5/24/95, 10/25/95, 4/22/98, 5/24/07, 8/28/08, 2/26/09, 6/23/11, 12/15/16) that were locally adopted, by the DBOH, but not federally approved since Source Registration and Operation 030.000 to 030.3104 were adopted in 1979 and some rules were revised in 2012. The SIP Submittal for the 9/26/24 adoption of CHAPTER 030 – Source Permitting and Operation (PARTS 030.000, 030.100, 030.200, 030.300, 030.400, and 030.500) will replace

Emergency Episode Plan, PARTS 060.010, 060.015, 060.020, and 060.025, have not been revised since they were adopted by the DBOH and approved by EPA in 1972. These PARTS are no longer applicable, are incorporated in CHAPTERS 020 and 050 (submitted to EPA for approval on August 17, 2022 and October 26, 2023, respectively), or are addressed via EPA-approved monitoring plans. The last approval of CHAPTER 050 by EPA was June 18, 2007.
