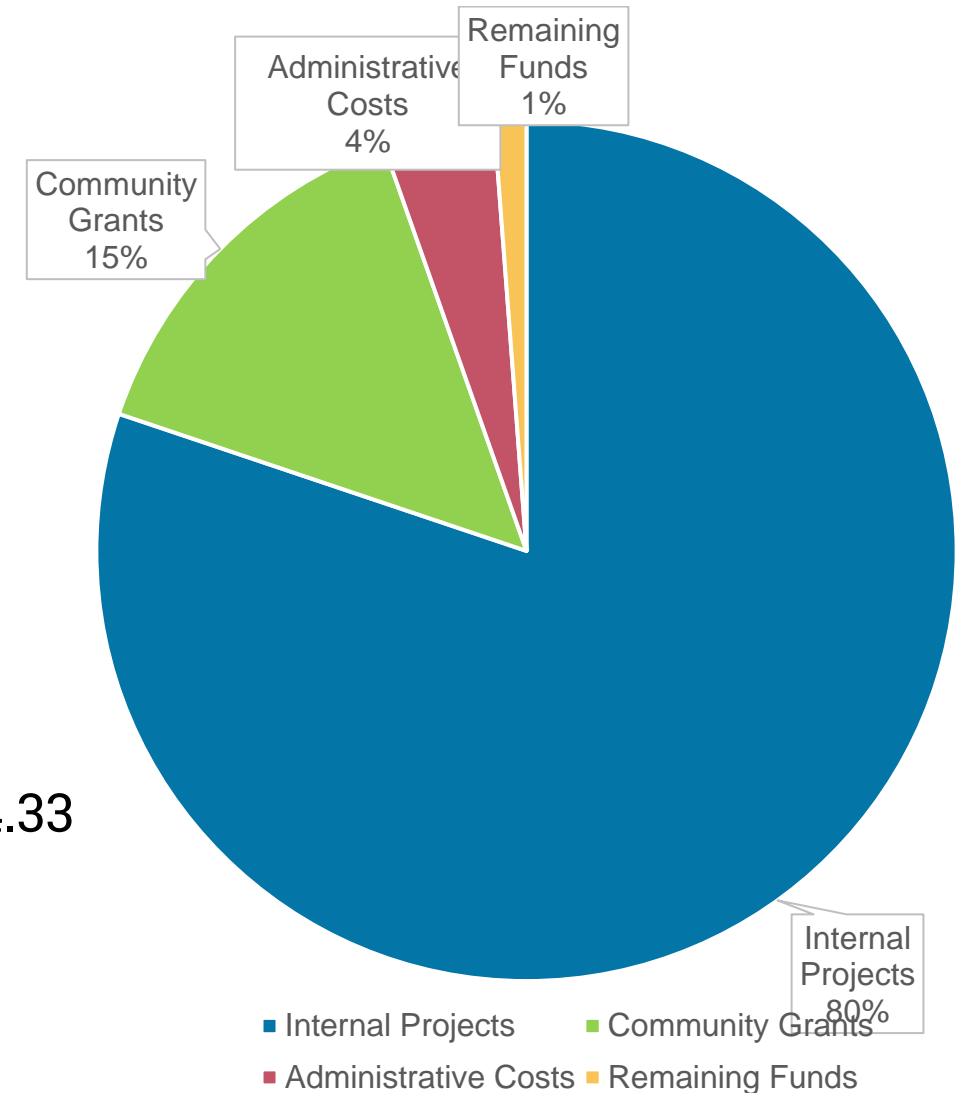
ARPA-SLFRF Update



Funding Status

- **Received:** \$91,587,038
- **Allocated Funds to Date:** \$90,485,241.37
 - **Obligated:** \$58,115,982.29
 - **Expended:** \$32,964,080.37
- **Remaining:** \$1,101,796.63
- 111 Projects Total
 - 59 Internal = \$73,419,797.04
 - 49 External Community Grants = \$13,229,444.33
 - 3 Admin Accounts = \$3,836,000

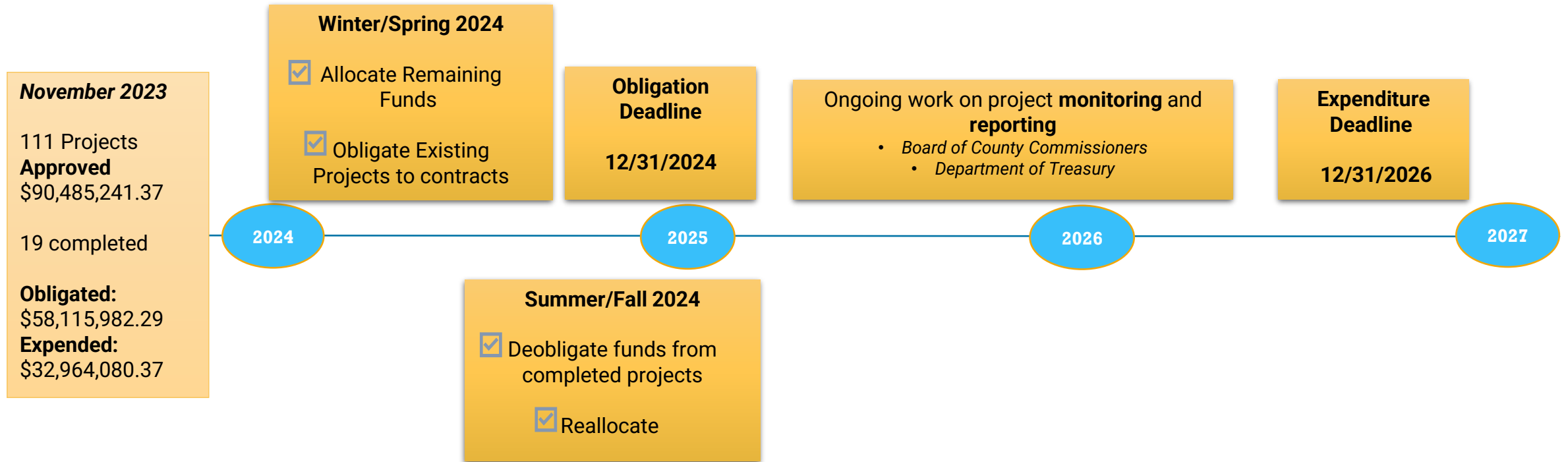
2023 Annual Report submitted to U.S. Treasury Dept.

Funding Status

- Opioid Settlement Recovered Funds to be received until approximately 2042
 - **\$41 million over the next 20 years**
- **\$2.8 million received** from the Attorney General's Office (as of October 2023)
- By 12/31/2023 - \$6.2 million available to distribute
 - subject to **annual reporting** and eligible use requirements.

Notice of Funding Opportunity – Spring 2024

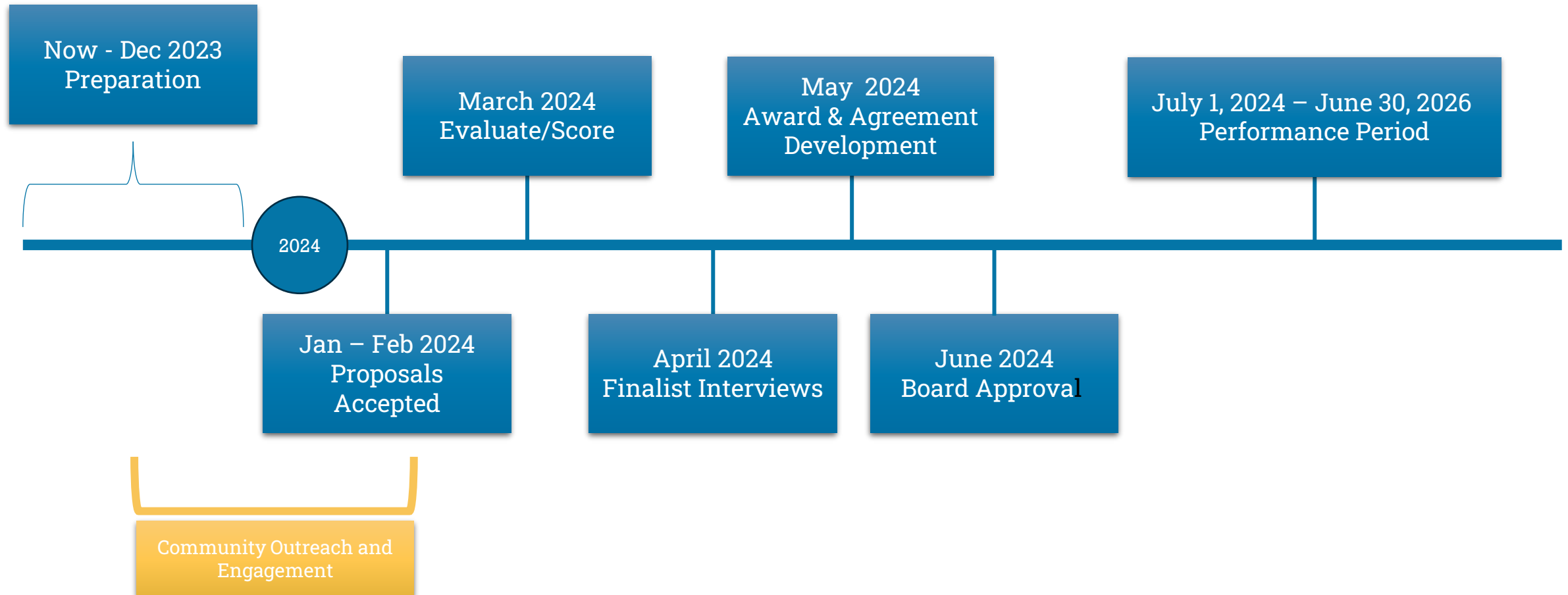
- Funding **priorities & allocations** based on:
 - *Washoe County Opioid Use/Opioid Use Disorder Community Needs Assessment; Washoe County Opioid Plan 2023-2025* - approved by BCC in December 2022
 - Updated every three years
- **Open competitive** grant awards
 - County departments*
 - nonprofit organizations
 - treatment providers
 - private entities

*Preference given to internal Washoe County projects

Fund Distribution

- Solicitation of grant proposals: **January 2024** (open 6-8 weeks)
- Anticipating ~**\$5.6 million** distributed to projects and programs
- **Up to 2-years funding allocations** (7/1/2024 – 6/30/2026)
- Second funding cycle, 3-years (7/1/2026 – 6/30/2029)

Timeline



Funding Priorities (from Needs Assessment)

Ensure funding for Opioid Use Disorder **services for uninsured and underinsured** Washoe County residents.

Incentivize providers to initiate **buprenorphine in the emergency department** and inpatient hospital stays.

Prevention **outreach and education to BIPOC communities** in a culturally and linguistically appropriate manner.

Implement **Child Welfare best practices** for supporting families impacted by substance use.

Increase **detoxification and short-term** rehabilitation program capacity

Evaluation and Selection Criteria

- **Evidence-based** or evidence-informed treatment
- Alignment with 2023-2025 **Needs Assessment** Priorities (link on website)
- Eligible Use under the **One Nevada Agreement**
- Advisory **Committee** (currently recruiting) will **review** and score proposals
 - Finalists to present to Advisory Committee
- Selections to be **approved by the Board of County Commissioners**
 - Both internal and external



Examples of Uses of Funds

- Expand **access to evidence-based prevention**/early intervention for persons at risk of substance use disorder,
- **Treatment for substance use disorders**, and support for persons in recovery;
- Programs to **reduce** the incidence and severity of **neonatal abstinence syndrome (NAS)**;
- Prevention of adverse childhood experiences (ACEs) and early intervention for children who have undergone adverse childhood experiences and their families;
- Services to **reduce the harm** caused by substance use;
- **Prevention and treatment of infectious diseases** in persons with substance use disorders;
- **Services for children** and other persons in a behavioral health crisis and their families; and
- **Housing** for persons who have or are in recovery from substance use disorders;

Examples of Uses of Funds (continued)

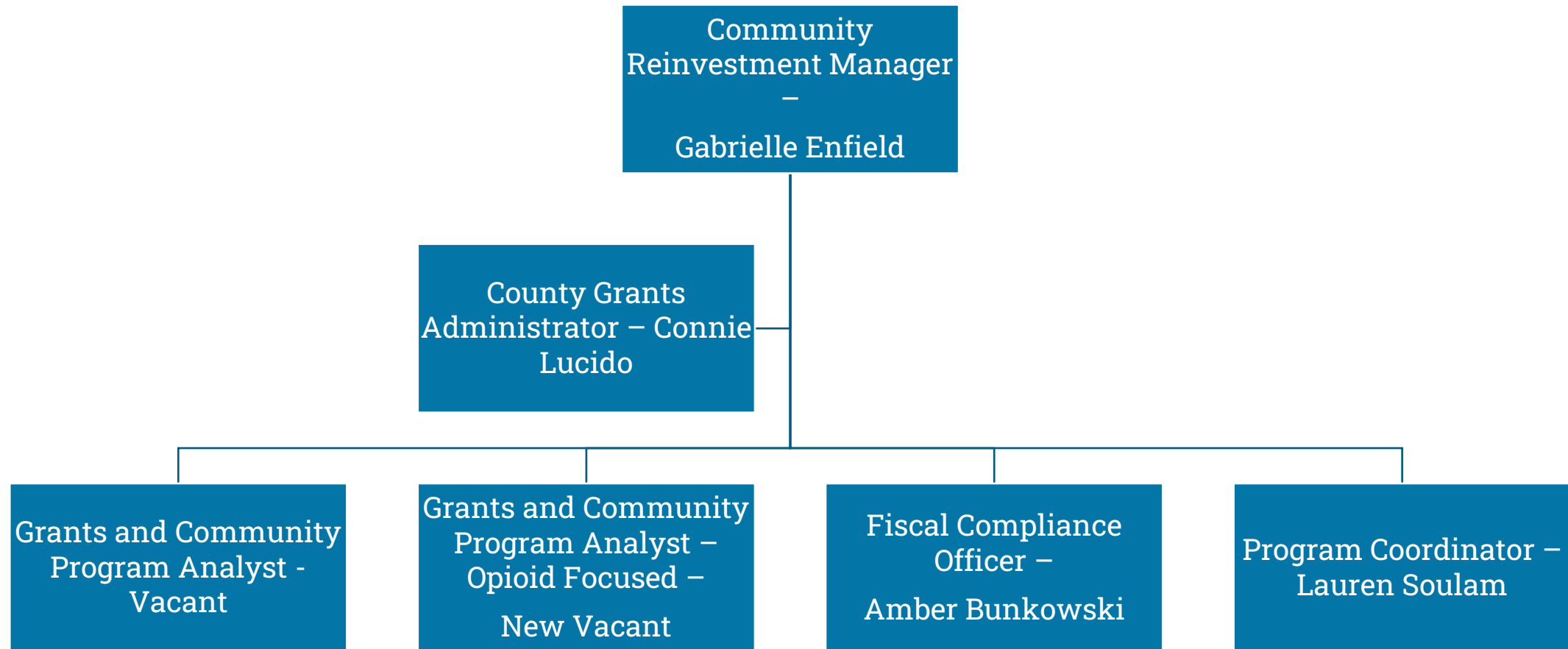
- Campaigns to **educate** and **increase awareness** to the public concerning substance use & substance use disorders;
- **Programs** for persons involved in the **criminal justice** or juvenile justice system and their families, including, programs that are administered by courts;
- **Evaluation** of existing programs relating to substance use and substance use disorders;
- **Development of the workforce** of providers of services relating to substance use and substance use disorders;
- The **collection and analysis of data** relating to substance use and substance use disorders;
- **Capital projects** relating to substance use and substance use disorders, including, construction, purchasing, and remodeling;

Discretionary Grant Facilitation & Assistance

- Identifying, coordinating and facilitating the development and submission of **grant applications** for current opportunities.
- Planning for future requests to meet priority needs.
- Identify **infrastructure funding** from the Bipartisan Infrastructure Law (BIL) and other American Rescue Plan Act competitive grants.
- **Grant writing** consultant to provide grant research and proposal development.

Discretionary Grant Facilitation & Assistance

APPLICATIONS AWARDED – 2023

- **Department of Alternative Sentencing for STAR, an opioid/substance abuse treatment program**
 - US Department of Justice: Substance Use Disorder Treatment and Recovery for Reentry grant - \$826,852 awarded over 4 years
 - Nevada Health & Human Services: Fund for a Resilient Nevada – \$365,146 awarded over 2 years
- **Human Services Agency for a program to support teens as they age out of the foster care system**
 - LifeSet grant - \$1,282,498 awarded over 4 years
- **Second Judicial District Court for their specialty courts diversion programs**
 - US Department of Justice: Justice and Mental Health grant - \$547,969 awarded over 3 years
 - US Department of Justice: Veterans Treatment Court grant – \$945,461 awarded over 4 years
- **Office of the County Manager Sustainability Department for Gerlach energy enhancements planning project**
 - US Department of Energy: Energizing Rural Communities Prize - \$100,000 awarded over 1 year

TOTAL AWARDED: \$4,067,926

- US Department of Transportation: Charging and Fueling Infrastructure Grant Program - \$2,722,495 for up to 7 years
