OVERVIEW

The 83rd Session of the Nevada Legislature ("session") began on February 3, 2025, and adjourned sine die at 12:35 a.m. on June 3, 2025.

On January 14, 2025, the Washoe County Board of County Commissioners approved the 2025 Washoe County State Legislative Principles. These principles provided the foundation to guide the activities of staff, lobbyists, and elected officials while representing Washoe County before the Nevada Legislature. In accordance with the 2025 Washoe County State Legislative Principles, Commissioners Alexis Hill and Jeanne Herman were named as liaisons to the Washoe County Legislative Team and met with County Manager Eric Brown and staff on a weekly basis during the Session to provide input and guidance on proposed legislation.

Throughout the course of the session, staff provided regular updates to the Washoe County Board of County Commissioners at each of the Board's regularly scheduled public meetings. At some of these updates, specific bills were identified for consideration of adoption of an official policy position by the Board. The Board adopted official policy positions on a total of six bills, which are discussed in greater detail in the highlighted legislation section of this report. As bills were considered by the Legislature, the Washoe County Legislative Team communicated positions on bills to legislators and other stakeholders and testified in legislative committee meetings. Positions were determined in accordance with the adopted 2025 Washoe County State Legislative Principles, the official policy positions adopted by the Board of County Commissioners, and positions of the County's Elected Officers when bills directly related to the jurisdiction of their respective office.

The Washoe County Legislative Team reviewed and monitored over 1,100 bills during the session. The County's final bill tracking list at the conclusion of the Session included 641 measures and 54 budget accounts. Governor Lombardo signed 519 bills into law and vetoed 87 bills. 40 resolutions were adopted and delivered to the Secretary of State.

MAJOR THEMES

The 1,254 bill draft requests submitted for the session covered a wide variety of subjects. Many of these measures focused on topics of interest to Washoe County including animal welfare, behavioral health, child welfare, elections, fire insurance, government administration, homelessness, housing, Lake Tahoe, public safety, sustainability, tax policy and workforce development. An list of the bills related to these topics may be found on the final pages of this report.

FISCAL IMPACT

Many of the bills introduced during the session included provisions that would have a fiscal effect on Washoe County. A total of 240 fiscal notes were submitted to the Legislative Counsel Bureau containing information on the estimated financial impact of bills on Washoe County, including revised fiscal notes on certain bills to reflect changes to the estimated fiscal impact of those bills as they were amended during the session. For some bills that would have a fiscal impact on Washoe County, a definitive estimate of the amount of the impact could be calculated. The specific dollar amount of the impact was included in the fiscal note submitted for those bills. Other bills were identified as having an impact, but because certain conditions or variables could not be quantified a reliable estimate of the financial effect could not be determined. In some cases, the financial impact of these bills to Washoe County could be significant.

For those bills that Washoe County was able to quantify a fiscal impact for, the tables below show the initial estimated fiscal impact of those bills as introduced and the final estimated fiscal impact of those bills in their final version. Details on the fiscal impact of individual bills may be found in the bill summary attached to this report.

STATE BUDGET

In addition to one-time appropriations contained in individual bills, funding increases in state budget accounts of interest to Washoe County were approved during the budget process. Of particular interest were the following:

Department of Health and Human Services – Washoe County Child Welfare Budget

- \$3.19M over the biennium to provide supportive services and direct financial support to young adults (aged 18 – 21) who had been in foster care as a child and choose to participate in the Extended Young Adult Support Services program.
- \$420,000 over the biennium to provide additional transportation services for youth in foster care.

Secretary of State and Help America Vote Act (HAVA) Budgets

- One-time general fund appropriations of \$23.52M for various expenditures related to the implementation of the Voter Registration and Election Management Solution, commonly referred to as VREMS.
- One-time general fund appropriations of \$3.5M for contract services to ensure the connection of Automatic Voter Registration agencies and costs to conduct mock elections for training and functionality verification.
- One-time general fund appropriations of \$1.5M for voter education campaign content, translation contract services and travel expenditures.
- One-time general fund appropriations of \$4.2M for Project Orion, the business licensing system modernization project.

HIGHLIGHTED LEGISLATION

The Washoe County Board of County Commissioners adopted an official policy position on the following five measures:

AB287

Position: Support

Final Status: Failed Passage

Summary: Revised the circumstances under which a candidate defeated at certain elections or a voter may demand a recount; requiring, under certain circumstances, that a recount for certain elections be conducted; requiring certain costs for certain recounts to be repaid from the Reserve for Statutory Contingency Account; creating the Voter Access Grant Program and the Account for the Voter Access Grant Program.

AB333

Position: Support

Final Status: Became Law

Effective Date:

Section 15 and Sections 11 and 13 effective May 30, 2025. Sections 1 to 10, inclusive, 12 and 14 effective on the day that the agreement between the Administrator of the Division of State Lands of the State Department of

Conservation and Natural Resources and Washoe County that is required pursuant to section 11 of the act takes effect.

Summary: Requires the Director of the State Department of Agriculture to establish the Nevada State Fairgrounds; creates the Account for the Maintenance and Operation of the Nevada State Fairgrounds; revises certain duties of the Nevada Junior Livestock Show Board relating to the real property leased to Washoe County for use as a fairground; terminates a lease for certain real property leased to Washoe County; requires the State Land Registrar to enter into an agreement to lease certain real property to Washoe County; requires the State Department of Agriculture to assume responsibility for the operation and maintenance of certain real property; repeals certain provisions of existing law governing the lease of certain real property to Washoe County.

SB65

Position: Support

Final Status: Failed Passage

Summary: Providing, with certain exceptions, that the final report of a coroner

concerning certain investigations of deaths is a public record.

SB73

Position: Support

Final Status: Failed Passage

Summary: Requires a county or city clerk to allow any person to inspect the signature of a registered voter; prohibits a county or city clerk from providing a copy or allowing a person to copy the signature of any registered voter.

SB319

Position: Neutral

Final Status: Became Law

Effective Date: Sections 15.5, 17 and 18 effective June 9, 2025. Section 15 effective June 9, 2025 and expires by limitation July 1, 2027. Sections 1 to 14, inclusive, and 16 effective on July 1, 2027.

Summary: Requires the Washoe County Board of County Commissioners, Reno City Council and Sparks City Council to establish a board to conduct a study relating to the creation of a county fire protection district within Washoe County and to prepare a report on the study findings and recommendations by December 31, 2026.

BILLS OF INTEREST

The bill tracking table attached as an appendix to this report contains summary information on bills of interest to Washoe County that were introduced and considered during the session. This table is not an all-inclusive list of every bill considered during the session that may have some relevance to Washoe County. Rather, the table is intended to provide information on those bills which most directly relate to the objectives of the Washoe County Strategic Plan, bills that require the County to take specific action(s), grant new authority to the County, and/or would have a fiscal impact on the County.

The summary information in the table does not necessarily address all provisions of each bill as some bills contain sections not directly applicable or otherwise of interest to Washoe County. The effective date listed for bills that passed and became law is the primary effective date(s) of the provisions of the bill most directly related to Washoe County. In some cases, certain sections of a bill may have an earlier effective date(s) for the purpose of adopting regulations or completing other administrative tasks necessary to implement the bill and/or a bill may have certain sections that become effective later than others.
