The Registrar of Voters received confirmation from the Nevada Secretary of State on March 7, 2025 of reimbursement eligibility; therefore, the request to accept this reimbursement is retroactive from July 1, 2024, through June 30, 2025. If approved, direct Finance to make the necessary budget amendments.

Washoe County Strategic Objective supported by this item: Fiscal sustainability.

PREVIOUS ACTION

No previous action has been taken on this item.

BACKGROUND

The Help America Vote Act (HAVA) of 2002 requires states to adopt a computerized statewide voter registration list. AB422 required the Secretary of State to establish and maintain a centralized, top-down database that collects and stores information relating to voter pre-registration and registration from all counties prior to the 2024 general election.

AGENDA ITEM #

During the 81st (2021) Legislative Session the VREMS project was initiated after the passage of AB422. The project puts in place a centralized statewide voter registration database and supports the connection of election management systems located in counties throughout the state to that database for secure and accurate elections.

The acquisition of additional charging carts was critical for implementing this project and maintaining the functionality of electronic devices used in voter registration and ballot processing at the vote centers for voter check-in. The use of these funds is strictly limited to use for the charging carts acquired in the 2024 General Election.

Scope of the Project: Reimbursement for charging carts

Benefit to Washoe County Residents: Every registered constituent in Washoe County who cast their vote in person at a vote center.

On-Going Program Support: These funds will supplement the costs associated with acquiring additional charging carts necessary for the 2024 General Election.
