recommended that Patricia Halstead serve as an attorney member for a two-year term expiring on January 31, 2026, and Cortney Young serve as a non-attorney member for a two-year term expiring January 31, 2026. Candidates will satisfy the attorney position and non-attorney position required for the Law Library Board of Trustees. Applicants for the attorney position include Patricia Halstead (incumbent) and Krissta Kirschenheiter. Applicants for the non-attorney position include Scott

Benton, Scott Finley, Rosanna Garibay, and Cortney Young (incumbent). For Possible Action. (All Commission Districts)

SUMMARY

Per WCC 10.070, the law library is governed by a Board of Law Library Trustees consisting of not less than five nor more than seven members. A maximum of three district court judges of the Second Judicial District Court, designated by all of the judges of the district from among their number, shall be ex-officio trustees. Two of the members of the board of trustees shall be licensed Nevada attorneys at law. The remaining two members shall be neither attorneys nor judges. The attorney and non-attorney members shall be appointed by the Board of County Commissioners at the first meeting of the Board each January, to serve for terms of two years. As nearly as possible, half of the terms must expire each year. The attorney members shall be appointed from a list of nominees supplied by the Board of Law Library Trustees, which list shall contain not less than two names for each attorney vacancy on the board of trustees. There are no term limits prescribed by law or by the Board bylaws. The Board of Trustees meets on a quarterly basis.

Two Board positions have terms expiring on January 31, 2024. One of those positions is specified in WCC 10.070(2) and must be filled by an individual with the following qualifications: a licensed Nevada attorney at law. The other open position is also specified in WCC 10.070(2) and must be filled by an individual that is neither attorney nor judge.

The notice to announce these open positions and accept applications was published on October 2, 2023. Applications were accepted from October 2, 2023 through October 31, 2023.

PREVIOUS ACTION

In 2018, the BCC appointed Clayton Brust to a fourth term as an attorney member of the Law Library Board of Trustees, Cortney Young to a first term as a non-attorney member of the Law Library Board of Trustees, and Kathi Lutsch to a one-year first term as a non-attorney member of the Law Library Board of Trustees.

In 2019, the BCC appointed Michael Kattelman to a third term as an attorney member of the Law Library Board of Trustees and Kathi Lutsch to serve her first two-year term as a non-attorney member of the Law Library Board of Trustees.

In 2020, the BCC appointed Patricia Halstead to a first term as an attorney member and Cortney Young to a second term as a non-attorney member expiring January 31, 2022.

In 2021, the BCC appointed Mike Kattelman to a fourth term as an attorney member and Kathi Lutsch to a third term as a non-attorney member expiring January 31, 2023.

In 2022, the BCC appointed Patricia Halstead to a second term as an attorney member and Cortney Young to a third term as a non-attorney member expiring January 31, 2024.

In 2023, the BCC appointed Mike Kattelman to a fifth term as an attorney member and Aurora Partridge to a first term as a non-attorney member expiring January 31, 2025.

BACKGROUND

The notice to announce these open positions and accept applications was published on October 2, 2023. The announcement was shared on the Washoe County Board & Commission webpage, in the Washoe County Bar Association's journal: The Writ, and a notification email was sent to 2,605 email subscribers via Washoe County's "Citizen Involvement" list. Applications were accepted from October 2, 2023, through October 31, 2023. A total of six applications were received in that time period and are attached to this staff report for the Board's review.

The following people applied for the attorney position: Patricia Halstead (incumbent) and Krissta Kirschenheiter. The following people applied for the non-attorney position on the Law Library Board of Trustees: Scott Benton, Scott Finley, Rosanna Garibay, and Cortney Young (incumbent). All the applicants were invited to speak at the Law Library Board of Trustees' public meeting on Wednesday, December 6, 2023. Mr. Finley and Ms. Kirschenheiter were both present and spoke at the meeting, while Mr. Benton stated he would be unavailable for the meeting and submitted comments to the Board ahead of time. The Board then voted on their recommendations. It is recommended by the Board that Patricia Halstead (incumbent) be reappointed to serve as an attorney member for a two-year term, expiring on January 31, 2026, and Cortney Young (incumbent) be reappointed to serve as a non-attorney member for a two-year term, expiring January 31, 2026.

FISCAL IMPACT

RECOMMENDATION

It is recommended that the Board of County Commissioners reappoint one attorney member and appoint one non-attorney member to the Law Library Board of Trustees. It is recommended that Patricia Halstead serve as an attorney member for a two-year term expiring on January 31, 2026, and Cortney Young serve as a non-attorney member for a two-year term expiring January 31, 2026. Candidates will satisfy the attorney position and non-attorney position required for the Law Library Board of Trustees. Applicants for the attorney position include Patricia Halstead (incumbent) and Krissta Kirschenheiter. Applicants for the non-attorney position include Scott Benton, Scott Finley, Rosanna Garibay, and Cortney Young (incumbent).

POSSIBLE MOTION

Move to approve reappointment of one attorney member and one non-attorney member to the Law Library Board of Trustees. Patricia Halstead will be reappointed to serve as an attorney member for a two-year term expiring on January 31, 2026 and Cortney Young will be reappointed to serve as a non-attorney member for a two-year term expiring January 31, 2026.
