BACKGROUND

The Washoe County Department of Juvenile Services and University of Nevada – Reno, School of Medicine seek to enter into a formal partnership whereby Adolescent Medical Students will conduct clinical rotation at Jan Evans Juvenile Justice Center - Wittenberg Hall. The Adolescent Medicine clinical rotation seeks to introduce learners to the field of adolescent health and medicine; providing learners with formative experiences in adolescent health supervision and clinical care; promote the development of learner competencies critical to quality adolescent health supervision and clinical care; and foster youth advocacy among learners.
