SUBJECT: Recommendation to accept the 2023 Victims of Crime Act (VOCA) [amount not to exceed \$7,365.00, no County Match required] as administered through the State of Nevada Department of Health and Human Services Division of Child Family Services, to be used to pay dues, travel, and training costs for the WCSO Victim Advocate, and to provide emergency housing and emergency services such as food and shelter for victims of domestic violence, for the retroactive grant period of July 1, 2022 – July 31, 2023, and if approved direct Comptroller's Office to make the necessary budget amendments. (All Commission Districts.)

SUMMARY

This funding is received from the Department of Health and Human Services, Division of Child and Family Services has provided funding through the Victims of Crime Assistance (VOCA) program to support and enhance the Washoe County Sheriff's Office Victim Advocate program by providing funds for travel and training, dues for the Victim Advocate, as well as funds for emergency housing and supplies for victims of domestic violence in our community. Emergency services such as food and clothing may be provided in the form of gifts cards tracked and issued by case numbers.
