### SUMMARY

Seeking the approval of the Board to settle the referenced claim against Washoe County and its employee for a total sum of \$150,000.00. Pursuant to Washoe County Code (“WCC”) 65.240(5), the Board has authority to settle any claim or suit for damages in this amount.

### PREVIOUS ACTION

There has been no previous action by the Board on this matter.

### BACKGROUND

This matter arose from the death of Rashad Kerr while in foster care. This litigation was initiated in 2022 by his natural mother and his estate against various defendants including Washoe County and several of its employees.

This settlement contains no admission of liability and will resolve all claims brought against Washoe County and its employees.

**RECOMMENDATION**
