The water rights at issue were originally dedicated to the county in connection with various use permits granted to Olson to operate 3 equestrian centers in the Warm Springs

area starting in 2008. (Commission District 4.)

#### **SUMMARY**

Pursuant to amendments to Washoe County Development Code, Chapter 110, Article 422, adopted on December 12, 2017, Washoe County is terminating three Water Sale Agreements between Washoe County and Ronald L. Olson Trust a.k.a. the Ronald L. Olson Revocable Trust of 2006, and re-conveying 18.89 acre-feet of water rights from Washoe County to the Ronald L. Olson Trust a.k.a. the Ronald L. Olson Revocable Trust of 2006.

# **BACKGROUND**

Beginning in 2008, Mr. Olson developed three equestrian centers in Warm Springs Valley. The projects he developed were subject to the provisions of Article 422 of the Washoe County Development Code which required the dedication to Washoe County of sufficient water rights to meet the project's water demands. Washoe County in turn would execute Water Sale Agreements to make the dedicated water rights available to these projects at no monetary cost. The deeds and agreements referenced in the "previous action" above is a summary of all such interaction between Washoe County and Mr. Olson's projects. Earlier this year, the County's dedication and lease back process was challenged by Mr. Olson by filing legal action in the Second Judicial District Court of the State of Nevada in and for the County of Washoe, identified as case # CV17-00555. A resolution without further litigation was sought. As a result, Washoe County amended its code to remove the mandate for the water rights dedication process and allow for re-conveyance of previously dedicated water rights. Olson, through counsel, has agreed to a dismissal of the lawsuit against the county once these water rights are reconveyed. The documents attached herewith accomplish the termination of the agreements between Washoe County and Mr. Olson and transfers title to said water rights back to Mr. Olson's Trust.
