RIDER NO. 1 COUNTY OF WASHOE, Reno, NV

The parties hereby agree to be bound to the terms contained in the Agreement for Elevator Preventative Maintenance and Repair between KONE Inc. ("Contractor") and (Washoe County "County") dated 1/1/2018 (the "Agreement"), together with those terms contained in this Rider No. 1.

Provided, however, that notwithstanding any terms contained in the Agreement to the contrary, in the event of conflict between terms contained in the Agreement and terms contained in this Rider No. 1, the terms in this Rider shall supersede and prevail.

1. Exhibit 1, Sec. 116: Add, "Notwithstanding anything to the contrary, Contractor's workshall not include any abatement or disturbance of asbestos containing material (ACM), presumed asbestos containing material (PACM) or other hazardous material (i.e. lead, PCBs) (collectively "HazMat"). Contractor shall have the right to discontinue its work in any location where suspected HazMat is encountered or disturbed. Any HazMat removal or abatement, or delays caused by such, required in order for Contractor to perform its work shall be Customer's sole responsibility."

This rider is for the above-referenced Project only and shall not be construed to be a course of dealing on future projects.
