SUMMARY

Recommendation to approve an increase the budget in the Travel line item by (\$10,000.00) and reduce the budget in the Professional Services line item in the same amount of (\$10,000.00) and increase the budget in the Meals and Lodging line item by (\$10,000.00) and reduce the budget in the Contracted/Temp Services line item in the same amount of (\$10,000.00).

BACKGROUND

Section 5.353(3)(c) of the Washoe County code states that "It is the department head's responsibility to make appropriate adjustments to the department's budget throughout the year to ensure sufficient funds are available in the department's travel account or special account to pay for such travel..."

Section 5.356(2) of the Washoe County code indicates travel reallocations, as outlined above, shall be "...reported to the county manager and the board of county commissioners at the next regular meeting of the board and recorded in the minutes of the meeting."

FISCAL IMPACT

There is no fiscal impact by moving a portion of the Professional Services line item budget (cost center C270731, account number 710100) to the Travel line item budget (cost center C270731, account number 711210) and moving a portion of the Contracted/Temp Services line item budget (cost center C270731, account number 710110) to the Meals and Lodging line item budget (cost center C270731, account number 711212). This is solely a house-keeping item to comply with Section 5.353(3) (c) of the Washoe County code.
