**SUBJECT:** Recommendation to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows, [staff recommends R Construction, in the amount of \$243,815.00]. (All Commission Districts.)

### SUMMARY

The 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows consists of constructing 26,000 square feet of 4 to 8-inch deep permanent pavement patches at identified locations, as well as other anticipated patches, within the Truckee Meadows area.

Sealed bids for the 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows Project were opened on April 3, 2018. The list of bids received for the project is as follows:

Staff has verified in the System for Award Management Exclusions that no bidder is excluded from receiving federal government contracts as a result of being debarred; thus, none of the bidders is prohibited by NRS 338.017(2) from being awarded a public works contract.

### **PREVIOUS ACTION**

On May 16, 2017, the Purchasing Manager awarded a bid and approved the Agreement to the lowest responsive, responsible bidder for the 2017/2018 Street Cut Pavement Repair Project for Truckee Meadows, R Construction, in the amount of \$81,590.00.

### **BACKGROUND**

The work consists of constructing 26,000 square feet of 4 to 8-inch deep permanent Hot Mix Asphalt (HMA) patches at identified locations, as well as other anticipated patches, within the Truckee Meadows area.

Work includes; mobilization, saw cutting of existing pavement, excavating, removing and legally disposing of the existing temporary asphalt patches, re-compaction of the existing aggregate base material so its suitable for pavement placement, tack coating, concrete collar replacement, placement and compaction of a Type 3 asphaltic pavement, all other incidental items, including raising of valves and manholes as required, and all other work in accordance with the general provisions and special provisions of this contract.

### **FISCAL IMPACT**

Washoe County Code chapter 85 - Street Cut Ordinance - provides a mechanism for the issuance of street cut permits, with fees collected to be utilized in pavement restoration and program administration. The Roads Special Revenue Fund (216) annual budget includes the street cut permit revenue as well as expenditure authority for the pavement restoration. Sufficient funds for this agreement are available in the FY 17/18 Roads Capital budget in cost center/account 216003-781080.

### **RECOMMENDATION**

It is recommended that the Board of County Commissioners award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows [staff recommends R Construction, in the amount of \$243,815.00].

### **POSSIBLE MOTION**

Should the Board agree with staff's recommendation, a possible motion would be. "Move to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows [staff recommends R Construction, in the amount of \$243,815.00]."
