SUBJECT: Recommendation to approve: (1) the purchase of three new replacement 66,000 GVWR Truck Cabs/Chassis from Velocity Truck Center, 1550 E. Greg St., Sparks, NV 89431 [\$119,137.00] utilizing Washoe County Bid #3007-17; and (2) the purchase of three new additional Williamsen-Godwin dump truck bodies each equipped with a hydraulics and tarping system, Henke HXC-2000 V-Box spreader and Henke reversible snow plow from Enoven Truck Body & Equipment, 2904 Duluth St., West Sacramento, CA 95691 [\$120,175.00] utilizing State of Nevada Bid No. 8548 pursuant to the joinder provision of NRS 332.195. (All Commission Districts.)

## **SUMMARY**

The Community Services Department (CSD) Equipment Services, through the Washoe County Purchasing and Contracts Manager, requests approval to purchase three new replacement 66,000 GVWR Truck Cab/Chassis from Velocity Truck Center, 1550 E. Greg St., Sparks, NV 89431 [\$119,137.00] utilizing Washoe County Bid #3007-17; and three new additional Williamsen-Godwin dump truck bodies each equipped with a hydraulics and tarping system, Henke HXC-2000 V-Box spreader and Henke reversible snow plow from Enoven Truck Body & Equipment, 2904 Duluth St., West Sacramento, CA 95691 [\$120,175.00] utilizing State of Nevada Bid No. 8548 pursuant to the joinder provision of NRS 332.195.

These units will replace existing units currently assigned to CSD Roads Operations which have reached the end of their useful lives.

Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities.

### PREVIOUS ACTION

On May 22, 2018, the Board of County Commissioners (Board) approved the Equipment Services fiscal year 2018/2019 budget authorizing Equipment Services to purchase replacement fleet vehicles/equipment using their Capital Purchases Budget from the Equipment Services fund.

### BACKGROUND

CSD Equipment Services seeks approval to utilize current Washoe County Bid No. 3007-17 and State of Nevada Bid No. 8548 pursuant to the joinder provision of NRS 332.195 to purchase three new 66,000 GVWR Truck Cab/Chassis equipped with Williamsen-Godwin 10 yard dump bodies, Henke salt/sand spreaders and Henke snow plows. These three units will be used in CSD Roads Operations. The three new trucks will replace three existing units which have been in service in excess of 15 years and have reached the end of their useful lives.

## FISCAL IMPACT

Replacement funds for this expenditure have been collected from CSD Roads Operations since the three existing units were put into service in 1999. FY 2019 has sufficient budget authority for this purchase in project number ES691902, account 781004.

## **RECOMMENDATION**

It is recommended that the Board approve the purchase of three new replacement 66,000 GVWR Truck Cab/Chassis from Velocity Truck Center, 1550 E. Greg St., Sparks, NV 89431 [\$119,137.00] utilizing Washoe County Bid #3007-17; and (2) the purchase of three new additional Williamsen-Godwin dump truck bodies each equipped with a hydraulics and tarping system, Henke HXC-2000 V-Box spreader and Henke reversible snow plow from Enoven Truck Body & Equipment, 2904 Duluth St., West Sacramento, CA 95691 [\$120,175.00] utilizing State of Nevada Bid No. 8548 pursuant to the joinder provision of NRS 332.195.
