SUBJECT:	Approve to accept a Victims of Crime Act (VOCA) grant to the District Attorney's Office in the amount of \$116,946 (\$29,237 required match), from the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS) to provide counseling services, victim services, and a part-time Victim Advocate; retroactive from July 1, 2018 through June 30, 2019. Direct the Comptroller to make the necessary budget amendments. (All commission districts)

SUMMARY

The District Attorney's Office received a Victims of Crime Act (VOCA) grant through the State of Nevada Department of Health and Human Services Division of Children and Family Service (DCFS), For Fiscal Year 2019; the District Attorney's Office received \$116,946 with a match of \$29,237 required. We have received VOCA funding for victim related personnel and services since 2003.

This grant is retroactive as this meeting date was the first available upon receiving the award documents.

County Strategic Objective supported by this item: Safe, secure and healthy communities

PREVIOUS ACTION

On November 28, 2017 the commission accepted a Victim of Crime Act (VOCA) grant to the District Attorney's Office in the amount of \$50,000 to provide victim services through the Washoe County District Attorney's Office Victim Witness Assistance Center.

On September 26, 2017 the commission accepted a Victim of Crime Act (VOCA) grant to the District Attorney's Office in the amount of \$50,000 to provide counseling services at the Washoe County Child Advocacy Center.

The Board has accepted VOCA grants on behalf of the District Attorney's Office since 2003.

BACKGROUND

The District Attorney's Office maintains a Victim-Witness Assistance Center (VWAC), which focuses on victim services for those in Washoe County. This center serves over 40,000 victims and witnesses annually with subpoenas, travel arrangements, scheduling of pre-trial appearances, and other victim services. The five victim advocates of the District Attorney's Office work diligently to ensure that our victims are educated about the process of the criminal justice system to include accompanying them to court appearances, providing referrals to various support and community organizations, assist victims in obtaining counseling, medical and dental care, protective services, psychiatric services, child care, food, clothing and related services. Our advocates also help our traumatized victims with assistance in preparing victim impact statements and collaborate with other professional and community service providers to meet victim's needs. Our advocates also maintain communication and continue to support victims through times of appeals, parole hearings, or post-conviction hearings.

The WCCAC opened its doors in June of 2014. The mission of the center is be to ensure the health and safety of the child through a neutral, child-centered environment designed to minimize trauma to the child, provide advocacy for the child and non-offending caregivers and support effective investigations. Within the center is housed the Sexual Assault Response Team (SART) and the Child Abuse Response and Evaluations (CARES) programs. Begun in October, 1999, these programs offer forensic examinations to adult and child victims of sexual assault. Alongside prosecutors, victim advocates, and investigators, the doctors and nurses provide specialized victims services. We added grant-funded counseling services in 2015. In fiscal year 2017-2018, the CAC has provided 1,350 on-site counseling sessions to victims and their families.
