### **SUMMARY**

The Washoe County Sheriff's Office has been requested to provide uniformed Deputy Sheriffs to aid with security during the 2018 Barracuda Open Golf Tournament, July 30, through August 5, 2018. The agreement provides for reimbursement to Washoe County for the cost of providing the uniformed Deputy Sheriffs.

### **PREVIOUS ACTION**

The Board has approved prior security agreements for this golf tournament on 7/28/15, 5/24/16, and 7/11/17.

### **BACKGROUND**

The Barracuda Open Championship Golf Tournament is an event being hosted at the Montreux Golf and Country Club. The event is organized and operated under the guidance of the Professional Golf Association and the Barracuda Open Foundation. The tournament will begin July 30 and continue through August 5, 2018. **FISCAL IMPACT**

All personnel and equipment will be paid for by the Barracuda Open. It is estimated that security costs will be \$64,000.00. Reimbursement received will be deposited to 150200-485129 (Office of the Sheriff/Salary Reimbursement).
