### **SUMMARY**

Approve Amendment #1 to the original Interlocal Agreement dated June 28, 2016 between Washoe County (Health District) and Washoe County (Department of Juvenile Services) concerning the clinical infrastructure of the Jan Evans clinic to provide appropriate adolescent health services for detained youth. Contract term retroactive from July 1, 2018 through June 30, 2021. This agreement is submitted for acceptance retroactively as this was the next available meeting upon receipt of contract.

### **PREVIOUS ACTION**

June 2016, the Board of County Commissioners approved the Interlocal Agreement between Washoe County (Health District) and Washoe County (Department of Juvenile Services) concerning the clinical infrastructure of the Jan Evans clinic to provide appropriate adolescent health services for detained youth with a contract term of 3 years.

### **BACKGROUND**

The goal of the Department of Juvenile Services is to provide and maintain optimal detainee health, including detection and treatment of communicable disease for the youth that are detained in Wittenberg Hall. The partnership with the Washoe County Health District will enable our Department to achieve such measure as the Heath District has the clinical experts and infrastructure to provide the best adolescent care services.

This agreement is submitted for acceptance retroactively as this was the next available meeting upon receipt of contract.

**FISCAL IMPACT**

There is sufficient FY 19 budget authority within Juvenile Services' internal order 11084, G/L account 710105-Medical Services, to account for payments made to the Health District for clinical services for youth detained at the Juvenile Services Detention facility. Estimated annual cost is \$5,000.
