SUBJECT: Approve an Interlocal Agreement for Garbage and Refuse Collection

between Washoe County and Sun Valley General Improvement District.

SUMMARY

Staff recommends the Board of County Commissioners approve an Interlocal Agreement for Garbage and Refuse Collection between Washoe County and Sun Valley General Improvement District.

Washoe County Strategic Objective supported by this item: Safe, Secure and Healthy Communities

PREVIOUS ACTION

On November 20, 2007 the Board of County Commissioners approved what was to be a temporary Interlocal Agreement between the County of Washoe and Sun Valley General Improvement District for the collection and disposal of garbage within the district.

BACKGROUND

In 2007 Sun Valley General Improvement District's franchise agreement with Independent Sanitation (Waste Management) was set to expire on October 31, 2007. The parties attempted to develop a new agreement but failed to do so prior to the date of expiration; at that time, the parties mutually agreed to extend the existing agreement an additional month to continue negotiations.

No agreement was reached and Sun Valley General Improvement District (District) staff and Washoe County staff collaborated to develop what was to be a temporary Interlocal agreement to maintain service to the District. That agreement is still in effect and does not outline specific provisions around payment calculation and timing.

The proposed agreement before the Board of County Commissioners replaces the former agreement and sets forth a structure for incorporation into the County's existing franchise agreement and payment of the District's franchise fees on a quarterly basis. This agreement was approved by the Sun Valley GID Board of Trustees on August 23, 2018.

FISCAL IMPACT

No additional fiscal impact; Washoe County has been intermittently remitting franchise fees to the District since the 2007 Interlocal was established. With the updated agreement payments will be made to the Sun Valley GID on a quarterly basis from Franchise Fees collected by Washoe County. Per the agreement, the Sun Valley GID will be determined based on the percentage of SVGID customers receiving service within Washoe County.

RECOMMENDATION

It is recommended that the Board of County Commissioners approve an Interlocal Agreement for Garbage and Refuse Collection between Washoe County and Sun Valley General Improvement District effective upon approval.

POSSIBLE MOTION

Should the Board of County Commissioners approve, a possible motion would be to "Approve an Interlocal Agreement for Garbage and Refuse Collection between Washoe County and Sun Valley General Improvement District effective upon approval".
