SUBJECT: Approve a 2019 Nevada State Emergency Response Commission (SERC), Operations, Planning, Training and Equipment (OPTE) grant for [\$29,000.00, no County match required] including funds to be used for food purchases and non-employee travel. Grant Term is retroactive to July 1, 2018 through June 30, 2019. If approved, authorize Chairperson to execute grant documents and authorize the County Manager or his designee, to sign Sub-Grant Agreement between Washoe County and the Reno Police Department (RPD) in the [amount of \$5,403.00]: approve Resolution necessary for same; and direct the Comptroller's Office to make the appropriate budget amendments. (All Commission Districts)

SUMMARY

Washoe County Board of County Commissioners (BCC) is requested to accept a 2019 Nevada State Emergency Response Commission, OPTE grant for [\$29,000.00, no County match required] from the State of Nevada SERC. The LEPC will subgrant these funds to member entities to provide training to local first responders and first receivers. Training and exercise topics covered will include Hazardous Materials Emergency Response and Hospital and Emergency Department Decontamination Procedures.

Staff is requesting a retroactive approval due to July 1, 2018 due to the timing of the receipt of the grant award and timing of BCC meeting opportunities.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

September 26, 2017 – The BCC accepted a 2018 SERC OPTE grant for \$29,000, and authorized the Chairperson to execute a Resolution to subgrant funds to other governments and nonprofits which make up the LEPC.

August 9, 2016 – The BCC accepted a 2017 SERC OPTE grant for \$28,961.00, and authorized the Chairperson to execute a Resolution to subgrant funds to other governments and nonprofits which make up the LEPC.

BACKGROUND

The source of funding is derived from fees collected from the Superfund Amendments and Reauthorization Act (SARA) Title III facilities within the State that store and/or produce hazardous materials. The grant provides funding to the Washoe County LEPC for planning/training initiatives, equipment purchases, and operational costs. This grant allocation intent is to improve state and local governments planning and response capabilities to react to Hazardous Material emergencies and to provide access to information about Hazardous Materials to the public.

Scope of the Project: *Prevention, mitigation and/or response to hazardous materials incidents.*
