SUBJECT: Accept a cash donation of [\$11,800.00 from Black Rock LLC] in support of increased demand for fire and emergency medical services associated with the "Burning Man" event and approve non-County Travel for volunteer fire fighter/emergency medical providers training; and if approved, direct the Comptroller's to make the appropriate budget amendments. (Commission District 5.)

SUMMARY

This staff report requests that the Board accept a cash donation in support of increased demand for fire and emergency medical services associated with the "Burning Man" event; and other matters related thereto [\$11,800.00 from Black Rock LLC]; and if approved, authorize Chairman to execute Resolution, and direct the Comptroller's to make the appropriate budget adjustments.

PREVIOUS ACTION

During the Commission's previous meetings, the Board directed staff to approve and accept the cash donations in support of increased demand for fire and emergency medical services associated with the "Burning Man" event several times over the past decade, with the most recent donations listed below:

August 13, 2013 - \$8,500.00

August 26, 2014 - \$8,500.00

October 20, 2015 - \$8,500.00

August 23, 2016 - \$8,500.00

September 19, 2017 - \$8,500.00

March 27, 2018 - \$2,500.00

BACKGROUND

The Gerlach Combination Fire Department has an increased operational posture and personnel requirements when the approximately 70,000 attendees descend into the Gerlach area for Burning Man. The Board has accepted donations from the Burning Man organization several times over the past decade. Most recently \$2,500 at the March 20, 2018 meeting, and \$8,500 at the September 19, 2017 meeting. These donations offset the staffing and training of these County, and non-County, personnel and equipment costs. Because the volunteers are not County Employees, the Board must approve in advance their attendance at the annual Rural EMS Conference.

Black Rock City, LLC, located in San Francisco CA, desires to help offset some of the costs associated with this increased need for Services and offers a voluntary, one time donation in the amount of \$11,800.00 (“Donation”) payable to County.

FISCAL IMPACT

This donation and the costs it supported will be recorded in Donation Internal Order 20356 in the Fire Suppression, Gerlach Division of the general fund. Budget amendments will need to be made in order to account for this donation to increase both revenues and expenses as follows:
