As outlined in SECTION 1 – TERM of the Agreement for the Provision of Paratransit Services for Senior Citizens and People with Disabilities – Washoe County Senior Services Gerlach and Incline Village Transportation Programs between the Regional Transportation Commission of Washoe County (RTC) and Washoe County by and through its duly constituted Board of County Commissioners, dated October 13, 2009, the RTC is exercising the option to extend this Agreement from July 1, 2018, through June 30, 2019. All of the remaining provisions of said Agreement dated October 13, 2009, shall remain in full force and effect.

The FY19 amounts are:

- Gerlach Senior Transportation: maximum \$12,000.00 (unchanged from FY 18)
- Incline Village Senior Transportation: maximum \$17,000 (unchanged from FY 18)


