BACKGROUND

This Agreement resolves a grievance regarding long-term assignments to perform Advanced Life Support duties per Article 42(f) specifically going to those employees who acted as paramedic when no firefighter paramedic was assigned to the engine for long term assignments. The Agreement defines long term assignment and the differential pay.

FISCAL IMPACT

The District contingency account includes \$300,000 for FY 2018-2019 The estimated FY 2018-2019 cost of the Settlement Agreement is approximately \$35,000 and includes retro payments from October 4, 2015 to current.

RECOMMENDATION

Staff recommends the approval of a Settlement Agreement between IAFF Local 2487 and Truckee Meadows Fire Protection District in the approximate amount of \$35,000 and to authorize the execution
