Fund 228 – Child Protective Services by moving [\$33,500] into the travel line item budget; [\$9,750] into the non-county travel line item budget and [\$13,000] into the food item budget (net impact to Child Protective Services

SUMMARY

Notify the Board of County Commissioners of the adjustments to the Human Services Agency travel line item budgets in Fund 228 – Child Welfare.

Strategic Objective supported by this item: Safe, secure and healthy communities

PREVIOUS ACTION

The Board previously approve adjustments to the FY18 Human Services Agency travel and food line item budgets on June 26, 2018.

BACKGROUND

The Agency is requesting retroactive authority to make the food purchases as they have already occurred however were not previously authorized.

Section 5.353(3)(c) of the Washoe County code states that "It is the department head's responsibility to make appropriate adjustments to the department's budget throughout the year to ensure sufficient funds are available in the department's travel account or special account to pay for such travel..."

Section 5.356(2) of the Washoe County code indicates travel reallocations, as outlined above, shall be "...reported to the county manager and the board of county commissioners at the next regular meeting of the board and recorded in the minutes of the meeting."

FISCAL IMPACT

A budget adjustment has been processed to reflect the changes below. These adjustments are net zero, no fiscal impact. This is solely a house-keeping item to comply with Sections 5.353(3)(c) and 5.356(2) of the Washoe County code.
