

RESOLUTION  
TO AUGMENT THE 2018-2019 BUDGET OF THE WASHOE COUNTY  
ROADS FUND

WHEREAS, total resources of the Washoe County Roads Fund were originally budgeted with an opening fund balance on July 1, 2018 of \$4,559,471.54; and

WHEREAS, the total resources for the Washoe County Roads Fund is now determined to have an opening fund balance on July 1, 2018 of \$10,813,952.08; and

WHEREAS, the Washoe County Roads Fund also has sufficient cash to meet these additional expenditures;

NOW THEREFORE BE IT RESOLVED, by the Board of County Commissioners of the County of Washoe, State of Nevada:

Section 1. That the budget of the Washoe County Roads Fund be augmented in fiscal year 2019 by increasing its appropriations as follows:
