Washoe County Library System will receive a state collection development award allocation of \$23,058 for FY 2019. This amount is based on the library's FY 2017 Local Collection Development Expenditures, as submitted through BiblioStat of \$904,794.

The awarded state funding can be used for the purchase of books, library materials, and computer databases. The money granted cannot supplant, nor cause to be reduced, any other source of funding for the public library.
