SUMMARY

The Nevada Division of Emergency Management, through the Department of Homeland Security has awarded the WCSO funding for the Citizen Corps Programs.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

Previous Citizen Corps Program grants were approved by the Board on 1/27/09, 2/23/10, 12/14/10, 4/23/13, 5/14/13, 11/12/13, 10/14/14, 10/13/15, 10/25/16 and 11/14/17.

BACKGROUND

Each year, the Nevada Division of Emergency Management sub grants funds received through the Department of Homeland Security to the Washoe County Sheriff's Office for various projects. These funds were awarded for our Citizen Corps Program and will be utilized to enhance the program by adding mobile tablets to the program as well as hydration backpacks for the volunteers.
