SUMMARY

The Washoe County Sheriff's Office's participates in the Nevada High Intensity Drug Trafficking Area (HIDTA) Task Force. The funding of these task forces is awarded to the Las Vegas Metro Police Department and operated by the HIDTA board. The Sheriff of Washoe County sits on this board. Funding received as a result of the board's decisions is used cover overtime, investigative, and travel expenses for participation of the Washoe County Sheriff's Office in the Northern Nevada Drug Task Force as part of the Nevada High Intensity Drug Trafficking Area (HIDTA) Task Force.

BACKGROUND

The mission of the HIDTA program is to disrupt the market for illegal drugs in the United States by assisting federal, state and local law enforcement entities participating in the HIDTA program in the dismantling and disruption of drug trafficking organizations.

Washoe County became part of Northern Nevada HIDTA Task Force in the fall of 2006, when the Board formally approved the Washoe County Sheriff's participation by way of interlocal agreement on November 13, 2006.

This travel was for the newly elected Sheriff to attend the HIDTA meeting along with the current Sheriff to help in transition to the Office.
