**SUBJECT:** Recommendation to approve receipt of a direct grant award [\$155,680.00,

no County match required] from the Bureau of Justice Assistance (BJA), State Criminal Alien Assistance Program (SCAAP), FY2017, Project number 2019-AP-BX-0219, to the Washoe County Sheriff's Office,

Detention Bureau. Beginning date of the grant term is retroactive to October 1, 2018, with no end date. If approved, direct the Comptroller's Office to make the necessary budget amendments.(All Commission Districts)

## **SUMMARY**

The Bureau of Justice Assistance SCAAP grant program awards funds to jail facilities for housing federal prisoners. These funds are awarded to the WCSO each year and are restricted to use for Detention Bureau activities and projects only. Grant funds have already been received up front. \$145,680.00 will be used within Detention to expand and enhance inmate services including mental health and opiate/drug addiction in the jail with the remaining \$10,000.00 for JBI professional services.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

#### PREVIOUS ACTION

The Board previously approved SCAAP funding on 12/16/08, 12/14/10, 9/27/11, 2/12/13, 12/9/14, 6/9/15, 1/26/16, and 1/10/17.

## **BACKGROUND**

The Washoe County Sheriff's Office receives SCAAP funding as reimbursement for housing federal prisoners. These funds are limited to use for Detention related projects and activities. Reason for retroactive submittal: This item is being submitted to the first available BCC meeting after allocation of funds was determined and Detention projects were assessed.
