To the Members of the Washoe County Commission:

In submitting my application, I am asking for your consideration to fill the open seat in Assembly District 30 in Sparks, NV. As a current resident of Sparks, an experienced broadcast executive, leader in non-profit organizations and a long time community advocate, I have the requisite qualifications and the broad spectrum of experience that will be needed to represent the demographics of this seat. I have resided in the district for a number of years and lived in Nevada for over 35 years. My intention is to represent the constituents of Assembly District 30 with integrity, dignity and respect.

As a former broadcast executive, the former President/CEO of the national award winning Hispanic Chamber of Commerce of Northern Nevada and the organizer for the Latino Leaders Roundtable, I am fully engaged in my community. During my various tenures as a nationally recognized community leader, I have stood up and stood forth in addressing issues that affect the community. I am stepping forward now, with a passionate desire to comprehensively serve the people of District 30.

My family moved from Puerto Rico to Northern Nevada in 1978, giving us a long history in the state. With the unusual background of having been born in the United States and brought up in Latin America and the Caribbean, I embraced the open deserts, the high Sierra mountains and the people of Nevada. My upbringing was primarily in the U.S. Commonwealth of Puerto Rico. Educated in Spanish, I was fully immersed in a broad understanding of cultural dimensions. My professional experience and personal background allows me a broad view across the many demographics in American society, especially in Nevada.

As a proud graduate of the University of Nevada, Reno I hold a B.A. in Journalism and Public Relations. My children were born and raised in Nevada. I have worked and lived in both Northern and Southern Nevada. Consequently, I gained statewide knowledge on some of the major issues that face Nevada such as taxes, population growth, water scarcity, use of public lands, gaming, business growth and diversity in economic development. One of my great joys is spending time with family and friends enjoying the many landscapes and open blue skies in our beautiful Nevada.

A valuable asset I would bring to the Assembly is my business acumen. As a respected business executive in broadcast and print media and the Chief Executive Officer of a Chamber of Commerce, I have a deep understanding of the economic

workings of Northern Nevada. The front line experience I have, has inspired me to become more involved in the public process.

Inclusive in my experience, is having worked as a Senate Committee Manager for the Legislative Council Bureau during the 2013 Session. This first hand knowledge of the full process at the Legislature would allow me to acclimate more easily in legislating for the duration of the 2019 Session. I have the in-depth knowledge that would allow me to quickly and effectively navigate the complexities of the Nevada State Legislature.

I work across the many spectrums of interest in our population. I have represented start-up businesses from dream to implementation, met the interests of big corporations that offer consumer products and employ large numbers of people, been a strong advocate for civic engagement and have been a champion for educational and economic success. Due to my work experience and personal life, I have a sound ability to address difficult issues with polarized opinions and find consensus among the parties.

One such example was working as a cohesive community on the redevelopment of Wells Avenue. Italian and Basque communities once populated the Wells Avenue neighborhood. The initial budget was set around \$2 million to repair a street that had been build 52 years prior. As is the nature of this avenue, these are small, individually owned businesses seeking to become part of the America dream. The Wells Avenue Merchant's Association started up during this project. Due to all of our hard work, combining resources and adhering to the collective vision, the neighborhood was eventually designated as a Historic District.

I chaired the Beautification Committee for Wells Ave and was instrumental in attaining federal funding for artwork, bicycle racks, sidewalk seating and landscaping along the sidewalks and roadways. By bringing in additional funding and community consensus for a vision for the avenue, we were able to increase the overall budget to approximately \$7 million. Working together with the businesses along Wells Avenue, the neighborhoods surrounding the avenue, local and national political representatives, in two languages no less, the street and neighborhood became the thriving area it is today.

Currently, I do consulting work for various enterprises. For many years, I was a consultant to former Reno Major Bob Cashell. Over the time, I have consulted on gaming projects in the sales and marketing of table games and gaming products. Working with small businesses to navigate the needed regulations and permits required, together we have been able to grow their businesses. I work on California Department of Transportation environmental, health and safety projects. Developing partnerships with stakeholders in media, social organizations, health and safety networks, law enforcement and community organizations is part of my

work. At present my job is to do outreach for Caltrans road construction projects around Lake Tahoe.

My platform is social equity being achieved through a solid educational foundation and access to strong economic progress. As a Democrat, I am fiscally conservative and socially progressive. I support and promote Democratic ideals with balance. The many peripheral issues surrounding business, economic development and education have often brought me to the forefront of political process, community engagement and representative leadership.

Sound government practices are the foundation upon which I believe we achieve a fair society with opportunity for all. I believe in equal representation across public platforms for people from all walks of our society. As an Assemblywoman, I would be representative of the constituents I would serve and the community in which I live.
