Application for District 30 Assembly Seat

To: The Commissioners of Washoe County

My name is Nancy Price. I am a registered Democrat. I have lived in District 30 most of my life. My two boys graduated from Sparks High School. I retired from the Nevada Air National Guard in Reno as Chief Master Sergeant. I worked at Nevada Bell for 14 years working on Plumb, Vassar and then was relocated to Las Vegas. I met my husband there who recently passed away former Assemblyman Bob Price.

When Bob lost his assembly seat to Kelvin Atkinson, we moved back to Sparks District 30. There is much of relevant information regarding my activities at the legislature as a citizen. Some of those activities resulted in changing the Nevada Constitution twice. The first audit of the university system required but never done by the legislature was completed. This was accomplished at my request with the leadership of Speaker Joe Dini. The BDR list, the publication of bill requests, resulted from a paper I wrote in graduate school. My education includes degrees from Truckee Meadows Community College, Community College of the Air Force (logistics and intelligence analyst), University of Nevada Las Vegas BA and MA and University of Nevada Reno (completed classwork for PhD in political science).

I was elected and served as Regent of the University System for six years. In that capacity achieved, with much turmoil, a court decision defining a meeting in the new technology age. In addition, requiring the publication of the system debt. This resulted in an increase in our bond rating saving millions of dollars. I won a contested Democratic Primary from Washoe County for the United States Congress.

I have a long view of Nevada political history allowing me to represent District 30 affectively and immediately. Please accept this brief resume as my request to replace the Assemblyman from District 30 for the current term only. This will allow a level field for candidates and the voters in 2020.
