Dear Washoe County Commission,

I am writing to inform you of my interest in being considered for the vacant Assembly seat in Assembly District 30. As I may be unfamiliar to some of you, I'd like to share a bit about myself, as well.

Those that know me best know that I devote my whole heart to whatever I do. I ran for Mayor of Sparks in 2018 as a nonpartisan and have served as the Legislative Director and At-Large Representative for the Libertarian Party of Nevada, though I am now a registered Democrat. I've also worked as a community organizer for NARAL, and when I ended my campaign for Sparks Mayor, I donated my remaining campaign funds to ACTIONN for their work protecting David Chavez-Macias and countless others.

My passion has always been building common ground between multiple parties, seeking stepwise policy changes that make people's lives better. During the 2017 Legislative Session, I worked with legislators and groups across the political spectrum - the ACLU, Americans for Prosperity, Nevadans for Electoral Reform, PLAN, TAG, NARAL, and many others - to advocate for policy that made a real difference for people in their day-to-day lives. While I hold my convictions deeply and strive to uphold the highest standards of integrity in both my personal and professional lives, I also understand the importance of both coalition-building and civility in our politics.

I know I'm not a traditional choice for this seat. Some may consider me a wild card. But I prefer to see myself as a potential bridge between the parties - I'm a fighter for civil rights, social justice, and individual freedom. I believe in a government big enough to help and small enough not to hurt. I believe that a person's survival should never depend on who their parents were, what's in their bank account, what they look like, or where they were born. And most importantly, I am a person of deep integrity. To paraphrase Maya Angelou, I do the best I can every day until I learn to do better - and then I do. If you give me the opportunity, I will devote myself wholeheartedly to the people of Assembly District 30.
