

**TRUCKEE MEADOWS FIRE PROTECTION DISTRICT
RESOLUTION TO AUGMENT THE DISTRICT'S FY 19/20 CAPITAL PROJECTS FUND CAPITAL
OUTLAY ACCOUNT BUDGET FROM THE CAPITAL PROJECTS FUND BEGINNING FUND
BALANCE ACCOUNT BUDGET IN THE AMOUNT OF \$200,000 FOR THE PURPOSE OF THE
PURCHASE OF AN AMBULANCE AND NECESSARY EQUIPMENT**

WHEREAS, the Board of Fire Commissioners have approved the District's FY 19/20 Consolidated Budget which includes a Capital Projects Beginning Fund Balance Account of \$3,036,401; and

WHEREAS, the District anticipated the purchase of an Ambulance and necessary equipment prior to June 30, 2019 and therefore this amount was not estimated in the Beginning Fund Balance Account and therefore not available for allocation in the FY19/20 budget; and

WHEREAS, the District did not purchase an ambulance prior to June 30, 2019, therefore increasing anticipated resources of Beginning Fund Balance Account above FY19/20 budgeted resources; and

WHEREAS, anticipated resources exceeding those estimated resources of the FY 19/20 Capital Projects Beginning Fund Balance account are available for use in the Capital Projects Capital Outlay account in accordance with NRS 354 and which appropriations are required to be augmented as follows:

WHEREAS, there is a need to reallocate the fiscal year 19/20 budget.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Truckee Meadows Fire Protection District shall augment its FY 19/20 budget by appropriating \$200,000 from the Capital Projects Fund Beginning Balance Account for use in the Capital Projects Fund Capital Outlay Account for the purpose of the purchase of an ambulance and necessary equipment, and further that the District shall forward the necessary documents to the Department of Taxation, State of Nevada.
