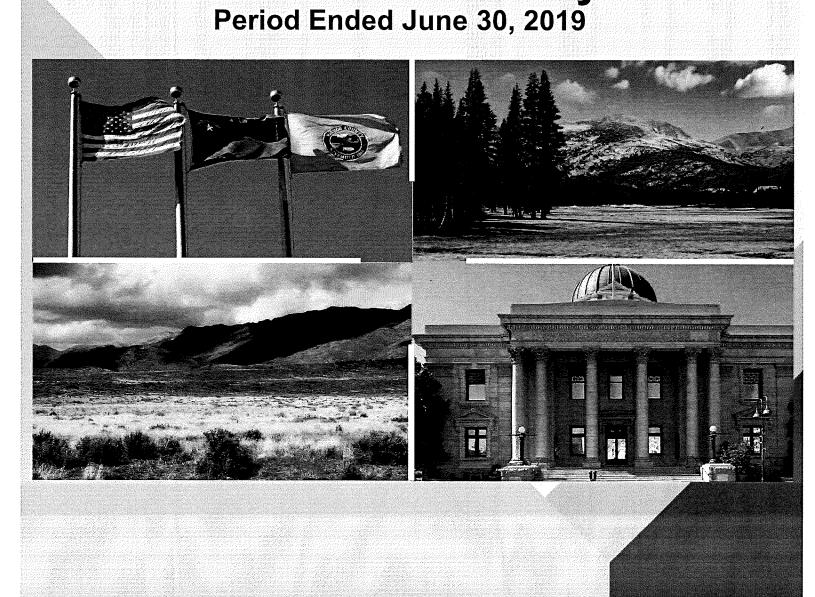

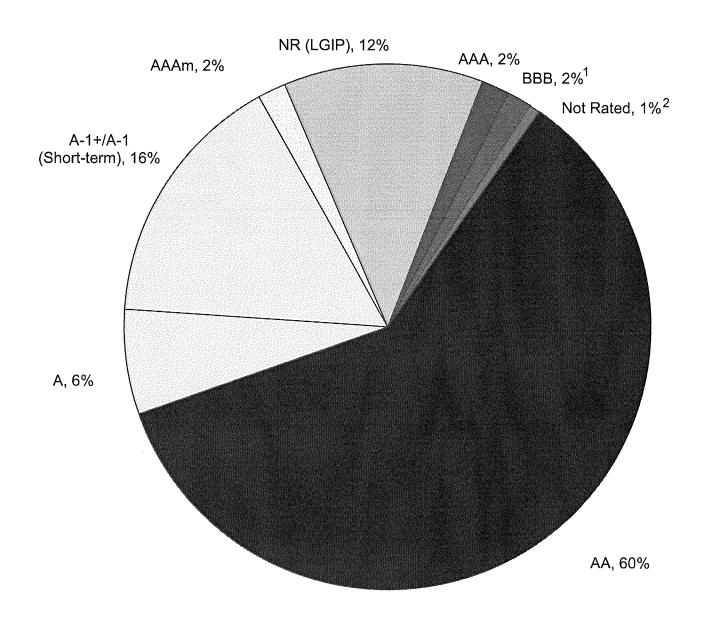

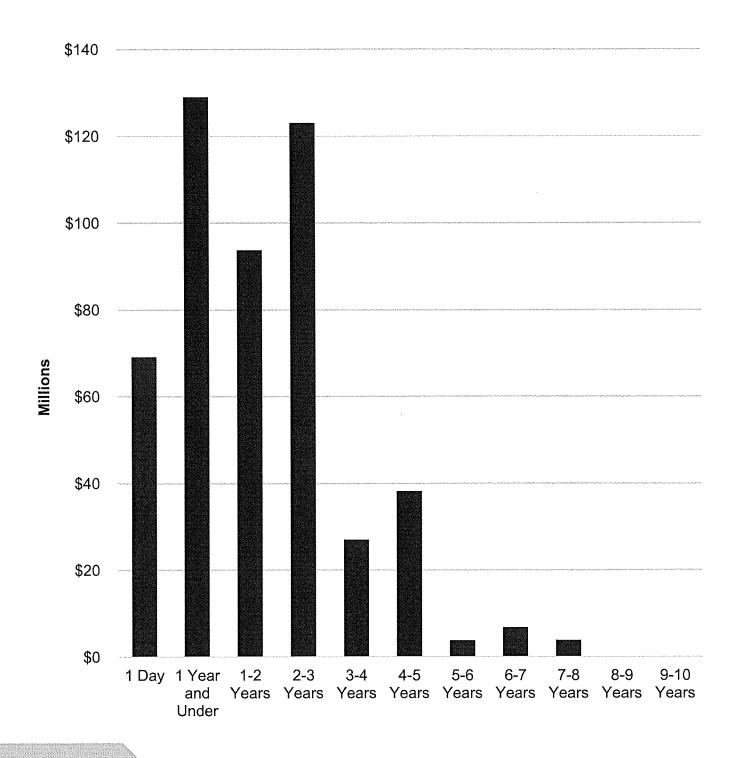
Portfolio Credit Allocation For the Year Ended June 30, 2019

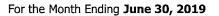
