GRANT AWARD SUMMARY

Project/Program Name: CDC Public Health Preparedness Program

Scope of the Project: The Grant Agreement was received on August 7, 2019 and was approved by the District Board of Health on August 22, 2019. The CDC award scope of work addresses the following capabilities:

- Community Preparedness
- Community Recovery
- Emergency Operations Coordination
- Emergency Public Information and Warning
- Fatality Management
- Information Sharing

- Medical Countermeasure Dispensing
- Medical Material Management and Distribution
- Public Health Surveillance and Epidemiological Investigation
- Responder Safety and Health
- Volunteer Management
- Program Administration

Benefit to Washoe County Residents: This Award supports the Epidemiology and Public Health Preparedness (EPHP) Division's mission to strengthen the capacity of public health infrastructure to detect, assess and respond decisively to control the public health consequences of bioterrorism events or any public health emergency.

On-Going Program Support: These funds support on-going activities in the Public Health Preparedness Program.

Award Amount: Total award amount is \$931,330 [\$846,664 direct/\$84,666

FISCAL IMPACT

As the FY20 budget was adopted with a total of \$920,693 in revenue (includes \$83,699 of indirect) and \$836,994 in expenditure authority, a budget amendment in the amount of \$9,670 is necessary to bring the Notice of Subgrant Award into alignment with the direct program budget.

No amendment is necessary for indirect revenue.
