**Description of Requested Change**

The state has requested that the county DIMS system be enhanced to add the following functionality:

**1) DIMS-23**

Nevada currently has online voter registration records coming into DIMS.net via a web service (NOVA). They are now adding the transmission of electronic voter registration records from the DMV.

The DMV records will be sent via the existing web service used for the NOVA transmissions, with the following changes **for DMV records only**. The NOVA transmission will not be changed.

1. Data validation will be removed based on the use of a new SubmitVoterRegistrationNoVal method. All records will be accepted into the queue for a county user to process even if they violate validation rules in place for NOVA transmissions.
2. The ValidateResidentialAddress method will not be called for DMV transactions. The address submitted will be stored in the review queue as sent.
3. Social Security number will not be required.
4. Drivers license numbers with alpha characters must be accepted.
5. Names will be accepted with the following special characters – apostrophe, hyphen, period, or space.

SA=12, Dev=84, QA=60, for a total of 156 hours

**IMPORTANT:** A test site will need to be set up for validating these changes Washoe County.

Additionally, a state testing representative will need to be available to the ESSVR QA department for testing these changes as well as access to the state sandbox (if available). ESSVR will notify the state 3 business days prior to when joint testing needs to occur. Any delay will impact the proposed timeline.
