Description of Requested Change

The state has requested that the county DIMS system be enhanced to add the following functionality:

DIMS-24

The Secretary of State's Office has changed the State of Nevada Voter Registration Application, specifically Boxes 9 and 13, and the changes need to be implemented in the NOVA interface.

IMPORTANT: A test site will need to be set up for validating these changes with Washoe County.

The NOVA changes are as follows:

1) Add a new property, one single field, named "SpecialStatus" to the existing "VoterRegistration" object, which goes into the existing "SubmitVoterRegistration()" service method that processes registrations. "SpecialStatus" consists of the three following values, of which the user can choose only one.

"MD" (for "Military Domestic") "MO" (for "Military Overseas") "CO" (for "U.S. Citizen overseas")

2) Add a second new property, one single field, named "Registration Date" to the existing "VoterRegistration" object.

3) Add a third new property, one single field, named "DocumentCode" to the existing "VoterRegistration" object.

NOTE: The following changes provide capability for potential future acceptance of unexpected fields in the XML messages describing the "VoterRegistration" object without having to do a major release.

4) Add a fourth new property, one single field, named "VariableField1" to the existing "VoterRegistration" object.

5) Add a fifth new property, one single field, named "VariableField2" to the existing "VoterRegistration" object.

6) These five new fields will be added to the fields we import and store in the DIMS.net.



7) These changes will be applied to the Automatic Voter Registration process in DIMS-23

SA=6, Dev=66, QA=33, for a total of 105 hours

IMPORTANT: A test site will need to be set up for validating these changes with Washoe County. Additionally, a state testing representative will need to be available to the ESSVR QA department for testing these changes as well as access to the state sandbox (if available). ESSVR will notify the state 3 business days prior to when joint testing needs to occur. Any delay will impact the proposed timeline.
