grant period of September 1, 2019 through August 30, 2020 and if approved, direct Comptroller's Office to make the necessary budget

This grant has been awarded to cover costs of bringing a Train-the-Trainer course to our community that will allow more community members to become certified Community Emergency Response Team (CERT) Basic Instructors.
