#### **SUMMARY**

The Washoe County Regional Medical Examiner's Office provides several types of examinations and consultations, as well as toxicology testing and other lab work for extra-jurisdictional government agencies, businesses, and citizens. Due to increasing costs, a fee analysis was performed and it has been determined that adjustments need to be made to the existing fee schedule.

#### **BACKGROUND**

Historically, Medical Examiner fees have been reviewed and updated in 2-3 year intervals. The Medical Examiner's Office has not reviewed or changed the fee schedule since March 2017. During that time, costs for personnel, benefits, services, and supplies have steadily increased. Also, due to changes made to public records laws during the 2019 legislative session, the fee for autopsy reports is being changed to actual cost.

#### **FISCAL IMPACT**

The proposed fee schedule update is estimated to generate approximately \$24,000 in Fiscal Year 2020, and \$48,000 in Fiscal Year 2021. Fees will be deposited to the General Fund (Cost Center 153010) using GL 460318|Toxicology Fees, 460341|Medical Examiner Fees, 485127|Professional Services Reimbursement, and 485300|Other Miscellaneous Government Revenue.
