SUMMARY

This staff report asks to approve the Washoe County Sheriff's Office to enter into an agreement with the University of Nevada, Reno to allow University of Nevada, Reno students to participate in Service-Learning, Internship or Field-Study Placement programs with the Washoe County Sheriff's Office.

BACKGROUND

The University of Nevada, Reno allows their students to participate and learn real life experiences through internship programs throughout the community. The Washoe County Sheriff's Office and the University of Nevada, Reno Criminal Justice program would like to partner and offer internship opportunities to Criminal Justice students interested in a career in public safety.

The Washoe County Sheriff's Office has offered individual internship opportunities for both high schools and colleges in years past on a case by case basis but both parties would like to formalize the process in an agreement.
