### **SUMMARY**

This staff report asks that the Board approve a three-year Interlocal Agreement with an option to extend one additional year between Washoe County on behalf of the Washoe County Sheriff's Office and the Washoe County School District on behalf of the Washoe County School District Police for emergency dispatch services.

### **PREVIOUS ACTION**

On March 27, 2012, the Board approved item 8.M (1). an Agreement with WCSDP for emergency dispatch services at Washoe High School and North Valley's High School.

### **BACKGROUND**

The Washoe County Sheriff's Office has been providing dispatch services for WCSDP since March 27, 2012. Both the Board of County Commissioners and the Washoe County School Board have approved the previous Interlocal Agreement to provide dispatch services.

### **FISCAL IMPACT**
