To the Washoe County Board of Commissioners:

I request that the Board of Commissioners select me to fill the remaining term of Trustee Phil Horan who resigned in December 2019.

There is little doubt that I am the best qualified candidate based on education, experience, temperament and availability to help manage the affairs of Incline Village. The stated duties of the Trustees are "to set policies and to determine strategies." This may also be described as providing vision and leadership to accomplish the goals of the community.

In my long professional career (43 years), which included managing partner of a large dental group practice as well as officer (and president) of local, state and national committees, I have developed a leadership style that could be described as thoughtful and insightful. In every society which I had the opportunity to participate, my leadership resulted in significant progress compared to the starting point. The key to successful management is communication and listening. It is counterproductive to waste precious time in conflict with others whose ideas might include an alternative way of problem solving. Better to discuss and come to a compromise before going public than pushing an unpopular agenda destined to be resisted or loudly criticized!

As a teacher, I was able to explain very complex concepts and open the door to understanding. The IVGID Trustees must educate the community whenever new projects are proposed, whenever expensive replacement/repairs of the existing must be undertaken, whenever unpopular changes to existing policy are required or whenever budgets seem to be larger than life. It takes skill and talent to bring along the most resistant within the community. Given the level of hostility exhibited at monthly meetings, some members of the community have not been adequately educated, giving rise to suspicion of ulterior motives. My communication skills will be of great benefit to the present Board of Trustees.

I have served on HOA boards for 11+ years in California and Nevada. In my capacity as member, committee chair and treasurer, I have experience in negotiating contracts, been concerned with fire safety, dealt with disgruntled owners, created budgets and managed to have surpluses without raising dues.

Whenever a new issue or problem is presented, I invest the time necessary to understand the situation from every angle. Seeking the advice of experts within IVGID or outside is one of the quickest ways to get up to speed. I know my limitations and am willing to consult with others more knowledgeable so that I can make informed decisions on a timely basis. Now that I am retired, I have the time to meet with groups or individuals as needed to review the issues and explain the reasons upon which decisions are made. It seems impossible for other candidates who are currently employed fulltime and who may also have family responsibilities, to dedicate sufficient time and attention to the affairs of IVGID.

Progress at Incline Village has been slowed and needed decisions to maintain even basic services have been delayed at times because of partisanship. The Board needs to be open to compromise in order to solve issues and present a feasible proposal to the residents. Currently pressing issues continue to be "postponed" because of lack of decision making. Many new projects have been proposed and now the community is anticipating completion, even though some proposals cannot be comfortably completed in a timely manner and within budgetary constraints. A more realistic schedule should be offered so that myopic individuals are made to understand that their pet projects will be addressed but only as time and money permit. I feel I have the negotiating skills and talent to bring together the members of the Board and the community who are resistant to change. I will assume a big role to navigate the process so that solutions will be found and implemented and that roadblocks to progress will be eliminated.

I am the best person to fill the vacancy created by the recent trustee resignation.
