## **SUMMARY**

This matter is brought to the Board to publicly acknowledge and approve the re-drafted minutes of the regular meeting of November 19, 2019 which have been revised on page 7 to more accurately reflect the public comments made by Mr. Cliff Low regarding agenda item 6.

### PREVIOUS ACTION

The minutes of the regular meeting of November 19, 2019 were first placed on the Board's agenda for approval on December 17, 2019. Due to a clerical error in the agenda for the December 17, 2019 meeting, the item for approval of the November minutes was pulled from the agenda.

#### BACKGROUND
