### SUMMARY

The Washoe County Sheriff's Office has received a gift donation of food (300 tri-tip individual meals with side servings) in the estimated value of \$6,000.00 from a private citizen on December 4, 2019 as a thank you to Sheriff's Office Personnel for a job well done.

**Washoe County Strategic Objective supported by this item:** Safe, Secure and Healthy Communities.

### PREVIOUS ACTION

On November 13, 2018 the Board approved item #10.B accepting an in-kind gift donation of food (2 dozen doughnuts) in the estimated value of \$25.00 from a private citizen on September 27, 2018 as a thank you to RAVEN for a job well done.

On October 16, 2018 the Board approved item #8.E.1, two in-kind gift donations of food and flowers valued at approximately \$380 from private citizens during Dispatcher Appreciation Week and Police Week in appreciation of services the employees of the Sheriff's Office provide to Washoe County Citizens.

On February 23, 2016 the Board approved item #8.C, a donation of \$19,000 in materials and labor to erect a Sheriff Memorial statue to honor and memorialize fallen Sheriff's Office employees.
