### **SUMMARY**

Washoe County Board of County Commissioners (BCC) approved the acceptance of a FFY19 State Homeland Security Program (SHSP) Continuity of Operations (COOP) grant. Based upon that acceptance, a request for proposal (RFP 3119-20) was issued. Approval is recommended to authorize awarding RFP to Anukra Consulting Group, LLC., in the proposed amount of \$107,000.

#### PREVIOUS ACTION

On November 12, 2019, the Board of County Commissioners accepted the 2019 Department of Homeland Security (DHS) grant passed through the State Homeland Security Program (SHSP) awarding [\$125,000.00 (no County match required)], for a Continuity of Operations and Continuity of Government project.

On November 12, 2019 the Washoe County Purchasing Office released a Request for Proposal (RFP) # 3119-20 for a Statewide COOP Plans Writer and Trainer with the intent of seeking proposals from qualified vendors
