SUMMARY

The Washoe Board of County Commissioners must approve amendments to the adopted fiscal year budget and direct the Comptroller's Office to make the appropriate budget amendments.

BACKGROUND

The Nevada Legislature passed Senate Bill 263 in the last legislative session. The Bill revises provisions relating to the regulation and taxation of certain vapor products, alternative nicotine products and tobacco products and appropriates \$2,500,000.00 annually for FY20 and FY21 from the State General Fund to the Department of Health and Human Services for distribution throughout the State. This request is retroactive as the Health District received the Subaward on February 18, 2020.

The District Board of Health accepted this subaward at their February 27, 2020 meeting.

GRANT AWARD SUMMARY

Project/Program Name: Youth Tobacco and E-Cigarette/Vaping Use Prevention

Scope of the Project: To support education, training, outreach, and messaging to decrease youth tobacco and e-cigarette/vaping use in Washoe County.

Benefit to Washoe County Residents: Reduce health risks of e-cigarettes and exposure to secondhand smoke aerosols.

On-Going Program Support: The program will continue to apply for funding to support the program.
