SUMMARY

This staff report asks that the Board/s discuss and consider approving an Interlocal Agreement between Washoe County on behalf of the Washoe County Sheriff's Office and the Truckee Meadows Fire Protection District for the testing and training connected to self-contained breathing apparatus (SCBA) Equipment.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

PREVIOUS ACTION

On June 26, 2018 the Board approved item number 6.I.1, the Sheriff's Office request to approve an Interlocal Agreement between Washoe County on behalf of the Washoe County Sheriff's Office and the Truckee Meadows Fire Protection District for the testing and training connected to Self-Contained Breathing Apparatus (SCBA) Equipment at a cost [not to exceed \$63 per hour] for the retroactive period of May 22, 2018 to May 21, 2020.

On April 28, 2015 the Board approved item number 5.I.5 , the Sheriff's office request to approve an Interlocal Agreement between Truckee Meadows Fire Protection District and

Washoe County, on behalf of the Washoe County Sheriff's Office, for the testing and training connected to Self-Contained Breathing Apparatus Equipment [at a cost not to exceed \$63 per hour] commencing April 21, 2015, and expiring April 20, 2018.

The Board of County Commissioners has approved this Interlocal Agreement since April 23, 2013.

BACKGROUND

Washoe County Sheriff 's Office maintains numerous self-contained breathing apparatus (SCBA) equipment on our property. Washoe County Sheriff 's Office is required per the Occupational Safety and Health Administration (OSHA 1910.134) to maintain the SCBA equipment and to annually inspect and test the SCBA under National Fire Protection Association (NFPA) standards and directives of the SCBA manufacturer.

Truckee Meadows Fire Protection District has the training, knowledge and qualifications to inspect and repair SCBA equipment in compliance with NFPA and OSHA standards. This Agreement allows both agencies to work together to meet OSHA and NFPA standards regarding SCBA equipment.

FISCAL IMPACT

During the remainder of FY 19/20 and for FY 20/21, FY 21/22 and for FY 22/23 budgets, any cost accrued will be covered within the existing operating budgets in Cost Center 150200 - 710205.

RECOMMENDATION

It is recommended that the Board of County Commissioners approve the Interlocal Agreement between Washoe County on behalf of the Washoe County Sheriff's Office and the Truckee Meadows Fire Protection District for the testing and training connected to Self-Contained Breathing Apparatus (SCBA) equipment at a cost [not to exceed \$63.00 per hour] for the period of May 22, 2020 to May 22, 2022 with an option to extend one additional year.

POSSIBLE MOTION
