SUBJECT:	Recommendation to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2020/2021 Encroachment/Excavation Repair Project for Truckee Meadows [staff recommends Sierra Nevada Construction, in the amount of \$288,200.00]. (All Commission Districts.)

### **SUMMARY**

The 2020/2021 Encroachment/Excavation Repair Project (Street Cut Pavement Repair) for Truckee Meadows consists of constructing 31,300 square feet of 4 to 8-inch deep permanent pavement patches for calendar year 2020 within the Truckee Meadows area.

Sealed bids for the 2020/2021 Encroachment/Excavation Repair Project for Truckee Meadows Project were opened on February 18, 2020. The list of bids received for the project is as follows:

Staff has verified in the System for Award Management Exclusions that no bidder is excluded from receiving federal government contracts as a result of being debarred; thus, none of the bidders is prohibited by NRS 338.017(2) from being awarded a public works contract.

Washoe County Strategic Objective supported by this item: Safe, secure and healthy communities.

### PREVIOUS ACTION

On May 16, 2019, the Board of County Commissioners (Board) awarded a bid and approved the Agreement with Vega Asphalt Paving, the lowest responsive, responsible bidder for the 2019/2020 Street Cut Pavement Repair Project for Truckee Meadows, in the amount of \$138,375.00.

On May 22, 2018, the Board approved the Capital Improvements Plan for Fiscal Years 2019-2023.

On May 8, 2018, the Board awarded a bid and approved the Agreement with R Construction, the lowest responsive, responsible bidder for the 2018/2019 Street Cut Pavement Repair Project for Truckee Meadows, in the amount of \$243,815.00.

## BACKGROUND

The 2020/2021 Encroachment/Excavation Repair Project (Street Cut Pavement Repair) for Truckee Meadows consists of constructing 31,300 square feet of 4 to 8-inch deep permanent hot mix asphalt patches for calendar year 2020 within the Truckee Meadows area.

Work includes: mobilization, saw cutting of existing pavement, excavating, removing and legally disposing of the existing temporary asphalt patches, re-compaction of the existing aggregate base material so its suitable for pavement placement, tack coating, placement and compaction of a Type 3 asphaltic pavement, incidental items as required, and all other work in accordance with the general provisions and special provisions of this contract.

# FISCAL IMPACT

Washoe County Code, Chapter 85 - Street Cut Ordinance - provides a mechanism for the issuance of street cut permits, with fees collected to be utilized in pavement restoration and program administration. The Roads Special Revenue Fund (216) annual budget includes the street cut permit revenue as well as expenditure authority for the pavement restoration. Sufficient funds for this agreement are available in the FY 19/20 Budget in Roads Capital (216003), Construction Contracts (781080).

### **RECOMMENDATION**

It is recommended that the Board of County Commissioners award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2020/2021 Encroachment/Excavation Repair Project for Truckee Meadows, [staff recommends Sierra Nevada Construction, in the amount of \$288,200.00].

# POSSIBLE MOTION

Should the Board agree with staff's recommendation, a possible move would be. "Move to award a bid and approve the Agreement to the lowest responsive, responsible bidder for the 2020/2021 Encroachment/Excavation Repair Project for Truckee Meadows, [staff recommends Sierra Nevada Construction, in the amount of \$288,200.00]."
