The Juvenile Justice Programs Office, Division of Child and Family Services (DCFS), has approved your State Fiscal Year 2021 Community Corrections Partnership (CCP) Block Grant in the amount of:

Please note that this funding is 100% state general funds and does not include any federal funding. Please ensure quarterly reports and performance measures are provided, as required. Templates are provided for your convenience.

The attached Notice of Sub Award (NOSA) will provide additional information, specifically about conditions of grant awards. Your signature, of that of a designee, is required prior to the release of any grant funds. An original signature is not necessary; an electronic signature on the document or scanned signed copy is acceptable.

NRS 62H.200 allows DCFS to withhold a percentage or all these funds for failure to comply with reporting requirements as outlined in NAC 62B, NAC 62H, established performance measures, and grant reporting criteria.

Before any funds are withheld, DCFS shall notify you of any lack of compliance and allow for a corrective action period. If those measures are unsuccessful, DCFS shall notify you of loss of funds to include the total amount of fund withholding. Funds withheld shall not be returned, but rather re-invested in the juvenile justice system in accordance with state law.

Due dates for quarterly reports for SFY 2021 is as follows:

1st Quarter- October 15, 2020


2nd Quarter- January 15, 2021
