SUBJECT: Recommendation to approve the Interlocal Agreement Extraditions between County of Washoe on behalf of the Washoe County Sheriff's Office and the City of Sparks on behalf of the Sparks Police Department in an amount not to exceed [\$35,000] to be paid to the Washoe County Sheriff's Office Consolidated Extraditions Unit for the processing of extraditions and transportation of prisoners for the Sparks Police Department, for the period of the date of execution to June 30, 2021.

SUMMARY

Washoe County Sheriff's Office processes extraditions and transports prisoners for the Sparks Police Department in accordance with the Interlocal Agreement Extraditions. The agreement in place will expire on June 30, 2020. This Interlocal Agreement Extraditions replaces that agreement and covers the period from the effective date up to and including June 30, 2021.

PREVIOUS ACTION

On November 19, 2019, the Board approved item #11.C.2., the Interlocal Agreement for Extraditions with the Sparks Police Department.

On May 23, 2017, the Board approved item #5.I.1., the Interlocal Agreement for Extraditions with the Sparks Police Department.

On August 23, 2016, the Board approved item #5.J.2., the Interlocal Agreement for Extraditions with the Sparks Police Department.

On October 8, 2013, the Board approved item #9H4, the Interlocal Agreement for Extraditions with the Sparks Police Department.

On October 12, 2010, the Board approved item #7J3, the Interlocal Agreement for Extraditions with the Sparks Police Department.

On November 13, 2007, the Board approved item #6N2, the Interlocal Agreement for Extraditions with the Sparks Police Department.

BACKGROUND

The Interlocal agreement establishing the Air Services Unit for extraditions services became operational in 2003. The prior Interlocal Agreement Extraditions between Washoe County Sheriff's Office and Sparks Police Department will expire June 30, 2020. Sparks Police Department wishes to replace the expired agreement with the Interlocal Agreement Extraditions that covers the period from the effective date up to and including June 30, 2021. The Interlocal Agreement Extraditions stipulates that Sparks Police Department may pay annually to the Washoe County Sheriff's Office pursuant to this Agreement shall not exceed \$35,000 per fiscal year, except that the Chief of Police of Sparks may authorize additional payments to WCSO pursuant to this Agreement. Sparks Police Department will calculate the amount owed to WCSO for each quarter and submit payment to WCSO within 60 days after the end of the quarter.

FISCAL IMPACT

No FY20/21 fiscal budget amendment is necessary as the revenue and expense for this activity is already budgeted in Cost Center 150710 | Extraditions.

RECOMMENDATION

It is recommended that the Washoe County Board of County Commissioners approve the Interlocal Agreement Extraditions between County of Washoe on behalf of the Washoe County Sheriff's Office and the City of Sparks on behalf of the Sparks Police Department in an amount not to exceed [\$35,000] to be paid to the Washoe County Sheriff's Office Consolidated Extraditions Unit for the processing of extraditions and transportation of prisoners for the Sparks Police Department, for the period of the date of execution to June 30, 2021.
