#### **SUMMARY**

Juvenile Services requests approval of the Certification Page and sponsor application between the County of Washoe (Juvenile Services) and the Nevada Department of Agriculture, Child Nutrition Programs to accept reimbursements from the National School Lunch and School Breakfast Program for Fiscal Year 2020/21 for meals served to youth detained at Wittenberg Hall Detention Facility. This item is submitted for acceptance retroactively as this was the next available meeting.

## PREVIOUS ACTION

On April 23, 2019, the Board of County Commissioners approved the Certification Page and Agreement between the County of Washoe (Juvenile Services) and the Nevada Department of Agriculture, Child Nutrition Programs, designating Christine Eckles, Division Director and Frank Cervantes, Director, as the authorized signers for the National School Lunch and School Breakfast Program. The board also authorized the application and acceptance of reimbursements from the program for Fiscal Year 2019/20 for youth detained at Wittenberg Hall Detention Facility.

On June 26, 2018, the Board of County Commissioners approved the Certification Page and Agreement between Juvenile Services and the Nevada Department of Agriculture, Child Nutrition Programs. The board also authorized the application and the acceptance of reimbursements from the program for Fiscal Year 2018/19 for youth detained at Wittenberg Hall Detention Facility.

October 2017 - Per the recommendation of Alison A. Gordon, former Washoe County Internal Audit Manager, and Gabrielle Enfield, County Grants Administrator, Juvenile Services should request Board approval to receive reimbursements from the 2018/19 National School Lunch Program for youth detained at Wittenberg Hall.

### **BACKGROUND**

The Nevada Department of Agriculture, through the National School Lunch and Breakfast programs, subsidizes all juvenile breakfast and lunch meals at Wittenberg Hall. Reimbursement is based on the number of juvenile meals served and verified by the Child Nutrition Program agreement. Actual reimbursements to Washoe County for FY20 were \$78,504.60; \$82,566.46 for FY19; \$97,261 for FY18; \$83,928 for FY17 and \$71,085 for FY16.
